

Minutes of Annual Meeting held on Wednesday 16 May 2007 at 12.00 noon

1. Election of Mayor. It was proposed by Councillor Thompson and seconded by Councillor Woodall:-

"That Mary Anne Pooley, a Councillor of this Borough be elected Mayor for the 2007/08 municipal year and until the election of Mayor at the next Annual Meeting of the Council."

It was accordingly:-

Resolved (unanimously): That Mary Anne Pooley, a Councillor of this Borough be elected Mayor for the 2007/08 municipal year and until the election of Mayor at the next Annual Meeting of the Council.

Councillor Pooley then made the statutory declaration of acceptance of office as Mayor. In her speech of acceptance, the Mayor reported that her nominated charities for the year would be People Matter and Open Door.

- **2. Minutes.** The minutes of the meeting held on 18 April 2007 were presented and the Mayor was authorised to sign them as a correct record.
- **3. Appointment of Deputy Mayor.** It was proposed by Councillor Tester and seconded by Councillor Purchese:-

- 4. Vote of Thanks. On behalf of the Council, Councillor Goodall and Councillor Stanley respectively proposed and seconded, a vote of thanks to the Councillor Belsey and Ms Anna Belsey for their service as Mayor and Mayoress. In response, Councillor Belsey thanked his Deputy Mayor, former Councillor, Mr Patrick Bowker, and reported that a total of over £32,000 had been raised for his nominated charity (the Eastbourne branch of the RNLI). The Mayor presented Councillor Belsey with his Past Mayor's Badge and Ms Anna Belsey with her Past Mayoress Badge.
- **5. Investiture of Mayor's Consort.** The Mayor reported that Mr Kiernan Pooley would undertake the duty of Mayor's Consort for the 2007/08 municipal year and duly presented the Consort's Badge to Mr Pooley.
- **6. Appointment of Mayor's Chaplain.** The Mayor reported that father barry Anderson of Christ the King Church, would be serving as the Mayor's Chaplain for the 2007/08 municipal year.

8. Election of Leader of the Council and Chairman of the Cabinet. As a result of a proposal from Councillor Harris, seconded by Councillor Stanley, it was:-

9. Cabinet Arrangements.

Councillor Neil Stanley (Deputy Leader and Deputy Chairman of Cabinet) - Responsibilities aligned to the Director of Finance, including benefits, audit and support services.

Councillor Margaret Bannister - Responsibilities aligned to the Director of Housing, Health and Community Services, including licensing, leisure, youth and theatres.

Councillor Steve Wallis – Responsibilities aligned to the Director of Economy, Tourism and Environment, including planning, regeneration and amenities.

Councillor Troy Tester - Responsible for special projects and Chief Whip.

10. Establishment of Council Committees, Appointment of Chairmen, Deputy Chairmen and Members to serve on the Council Committees and appointment of Chairmen and Non-Executive Directors to Boards. The Council noted the report of the Local Democracy Manager on political balance and allocation of seats. As a result of this, together with the outcome of a meeting of the two Group Leaders and Deputy Leaders, a proposed schedule of Chairmen, Deputy Chairmen and Members of Council Committees was circulated.

Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

Resolved (unanimously): That the remaining establishment of Council Committees, the appointments of Chairmen, Deputy Chairmen and Members to all Council Committees and the appointment of the Chairman and Non-Executive Directors to Boards, be approved in accordance with the names listed on the schedule attached to these minutes.

11. Confirmation of Programme of Meetings for Council Bodies. Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

Resolved: That the programme of meetings for all bodies in the Council's structure for the 2007/08 municipal year be confirmed in accordance with the schedule circulated with the agenda for this meeting subject to a correction to the dates for the Conservation Area Advisory Group (delete 1 January 2008 and replace with 2 January 2008).

13. Delegation of Functions to Council Committees. Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

Resolved: That the scheme of delegation of functions of all Committees of the Council for the 2007/08 municipal year, as set out in Part 3 of the Council's Constitution, be approved.

14. Appointments to Outside Bodies. Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

Resolved: That the appointments of persons to serve on outside bodies be approved in accordance with the names listed on the schedule attached to these minutes.

15 Members' Allowances. The following motion was moved by Councillor Tutt and seconded by Councillor Harris:

That the Council, at their Annual Meeting, re-consider the report of the Council's Independent Remuneration Panel dated 12 December 2006 which was previously submitted to Council on 17 January 2007.

That with immediate effect the Council resolves to amend the Members' Allowances Scheme in respect of the Councillors' Basic and Special Responsibility Allowances to specify those provided for under the Council's old scheme and at the amounts paid during the 2006/7 financial year, plus 2.7%.

The following amendment was moved by Councillor Marsden and seconded by Councillor Belsey:

That the budgetary saving arising from this motion be placed within the strategic change fund and that it be earmarked specifically for a possible contribution towards the costs of a judicial review if the decision of the Primary Care Trust regarding core services delivered from the Eastbourne District Hospital goes against the wishes of Eastbourne residents.

The amendment was put to the vote and with 7 votes in favour and 18 votes against was declared LOST.

The motion was then put to the vote and was **APPROVED** (with no votes against).

16 Parking. The following motion was moved by Councillor Tutt and seconded by Councillor Bannister:

That Eastbourne Borough Council resolves to withdraw all support for the "Pay to Park" scheme planned for Eastbourne. It will immediately inform East Sussex County Council of this decision and request that the scheme is withdrawn. In addition to this action the Council calls upon The Secretary of State for Transport to recognise the fact that the majority of residents in *Eastbourne oppose the scheme and requests that he uses his powers to veto the proposals submitted to him by East Sussex County Council.*

The motion was **APPROVED** (by 18 votes to 1)
