# Minutes of the Annual meeting held on Wednesday 21 May 2008 at 6.00 pm

Present:-

**1. Election of Mayor.** It was proposed by Councillor Tutt and seconded by Councillor Heaps:-

"That Gregory John Michael Szanto, a Councillor of this Borough be elected Mayor for the 2008/09 municipal year and until the election of Mayor at the next Annual Meeting of the Council."

It was accordingly:-

**Resolved:** That Gregory John Michael Szanto, a Councillor of this Borough be elected Mayor for the 2008/09 municipal year and until the election of Mayor at the next Annual Meeting of the Council.

Councillor Szanto then made the statutory declaration of acceptance of office as Mayor. In his speech of acceptance, the Mayor reported that his nominated charity for the year would be the Eastbourne and District Alzheimer's Society. He also reminded the Civic Pparty that all were invited to a dedicated mass at Our Lady of Ransom Church on Sunday 8 June 2008 at 10.30am.

- **2. Minutes.** The minutes of the meeting held on 30 April 2008 were presented and the Mayor was authorised to sign them as a correct record.
- **3. Appointment of Deputy Mayor.** It was proposed by Councillor Tester and seconded by Councillor Harris:-

"That Harun Miah, a Councillor of this Borough be appointed Deputy Mayor for the 2008/09 municipal year and until the next Annual Meeting of the Council."

It was accordingly:-

**Resolved:** That Harun Miah, a Councillor of this Borough be appointed Deputy Mayor for the 2008/09 municipal year and until the next Annual Meeting of the Council.

Councillor Miah then made the statutory declaration of acceptance of office as Deputy Mayor. He confirmed that Mrs Razia Miah and Mrs Irene Sims would continue to act as his Deputy Mayoress and Consort respectively.

- 4. **Vote of Thanks.** On behalf of the Council, Councillor Woodall and Councillor Thompson respectively proposed and seconded, and Councillor Elkin endorsed, a vote of thanks to Councillor Pooley and Mr Kiernan Pooley for their service as Mayor and Mayor's Consort. In response, Councillor Pooley thanked her Deputy Mayor and reported that a total of £10,000 had been raised for her nominated charities, Open Door and People Matter. The Mayor presented Councillor Pooley with her Past Mayor's Badge and Mr Kiernan Pooley with his Past Mayor's Consort Badge.
- **5. Investiture of Mayoress.** The Mayor reported that Mrs Clare Szanto would undertake the duty of Mayoress for the 2008/09 municipal year and duly awarded the Mayoress' Chain and Badge to Mrs Szanto.
- **6. Appointment of Mayor's Chaplain.** The Mayor reported that Canon Seamus Hester of Our Lady of Ransom Church, would be serving as the Mayor's Chaplain for the 2008/09 municipal year.
- **7. Apologies for Absence.** Apologies for absence were reported from Councillors Goodyear and Purchese.
- **8.** Election of Leader of the Council and Chairman of the Cabinet. As a result of a proposal from Councillor Stanley, seconded by Councillor Harris, it was:-

**Resolved:** (Nem Con) That Councillor David Tutt be elected Leader of the Council and Chairman of the Cabinet for the 2008/09 municipal year.

- **9. Cabinet Arrangements.** Councillor Tutt reported that Cabinet would be made up from the Councillors and portfolios as shown on the schedule attached to these minutes for the 2008/09 municipal year. In naming his new Cabinet, Councillor Tutt placed on record his thanks to Councillor Stanley for his contribution as Deputy Leader and Cabinet member in 2007/08.
- 10. Establishment of Council Committees, Appointment of Chairmen, Deputy Chairmen and Members to serve on the Council Committees and appointment of Chairmen and Non-Executive Directors to Boards. The Council noted the report of the Local Democracy Manager on political balance and allocation of seats. As a result of this, together with consultation with Group Leaders, a proposed schedule of Chairmen, Deputy Chairmen and Members of Council Committees was circulated.

Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

**Resolved:** (1) That the establishment of Council Committees, the appointments of Chairmen, Deputy Chairmen and Members to all Council Committees and the appointment of the Chairman and Non-Executive Directors to Boards, be approved in accordance with the names listed on the schedule attached to these minutes.

- (2) That the existing independent members of the Standards Committee, Mr Jaye Libeccio (as Chairman) and Mr John Vesely be re-appointed for the 2008/09 council year.
- **11. Confirmation of Programme of Meetings for Council Bodies.** Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

**Resolved:** That the programme of meetings for all bodies in the Council's structure for the 2008/09 municipal year be confirmed in accordance with the schedule circulated with the agenda for this meeting.

**12. Delegation of Functions to Council Committees.** Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

**Resolved:** That the scheme of delegation of functions of all Committees of the Council for the 2008/09 municipal year, as set out in Part 3 of the Council's Constitution, be approved.

**13. Appointments to Outside Bodies.** Following a proposal from Councillor Tutt, seconded by Councillor Elkin, it was:-

**Resolved:** That the appointments of Members to serve on outside bodies be approved in accordance with the names listed on the schedule attached to these minutes.
