Purpose of Report:

Information

- 1 The Scrutiny Committee met six times during the municipal year 2006/07.
- The Scrutiny Committee additionally met as a Call-In Panel to discuss a proposed grant to Dove 2000 Limited and its recommendations were accepted by Cabinet (Minute 135).
- The Committee's work programme, as agreed by Council on 27 September 2006 and subsequently updated regularly, is at Appendix 1.
- **4** Scrutiny Panels completed three Reviews during the period, namely:
 - Housing Benefits
 - Newhaven Fort
 - Partnerships

which were presented to Cabinet. Recommendations within were accepted to varying degrees and have led in some cases to ongoing work. The Committee thanks those councillors and officers who contributed to those reviews.

- In April 2007 councillors, Corporate Management Team officers and the chairs of the Area Partnerships were canvassed for suggestions for the Committee's Work Programme 2007/08. All new councillors received a 'suggested topic for review' form in a Scrutiny pack distributed following a training session in May 2007. Ongoing work and resultant proposed new work is detailed for Council's approval in the Committee's Draft Work Programme (Appendix 2) which has previously been submitted for comment to Cabinet and the Corporate Management Team.
