### Point 1.

The policy says:

"6.4.7 WASTE

Complaints relating to the accumulation and storage of waste will be dealt with under the provisions of the Environmental Protection Act 1990 and the Refuse Disposal (Amenity) Act 1978."

There are a variety of different pieces of legislation that may be used to deal with complaints about waste and different aspects of it, e.g., The Environment Act 1990, the Clean Neighbourhoods and Environment Act 2005 (accepted these mainly modify the Environmental Protection Act for waste), The Control of Pollution (Amendment) Act 1989, The Prevention of Damage bty Pests Act, the Food Safety Act 2006 and a variety of other pieces of legislation including Public Health and Planning Acts. We have (or are close to having) a Council enforcement policy. It strikes me that the wording in this document is unnecessary and potentially restricting the Council's ability to act in any other ways than listed here on licensed premises. Not only that it may directly contradict the enforcement policy. May I please suggest that the paragraph is either taken out or simply put "appropriate legislation".

#### Point 2.

### Data Protection, Information and National Fraud Initiative.

You have not included any information about data and its uses. Under Personal Licences (Licensing Act 2003) Sue Pattenden has been doing some very helpful work to help comply with National Fraud initiative work and the Code of Data Matching Practice issued by the Audit Commission;

The National Fraud Initiative requires us to have 'Fair Processing Notices' to let people know that we will be using their data and sending it to e.g., the Audit Commission. Sue has also typed up a new application form (exactly copying the DCMS statutory form) and included the NFI paragraph right at the top of the form. This is so that if Sue Lindsey sends out an electronic version via email or in the post at least this form has the paragraph inserted.

The only thing she had yet to do (which she was in the process of doing last I spoke with her, as Garry Clark was back from leave & had been able to supply her with the text content) was updating our website page to include information relating to Personal Licence Applications & Iain Griffin was going to insert a 'flag' on the website which will come up with the NFI paragraph).

May I suggest that you include this within your policy document.

The suggested wording in the Code of Data Matching Practice is:

Level 1 - Summary Text - Example for Application Forms (for example, for benefits, housing tenancies, employment, market traders and taxi drivers)

"This authority is under a duty to protect the public funds it administers, and to this end may use the information you have provided on this form for the prevention and detection of fraud. It may also share this information with other bodies responsible for auditing or administering public funds for these purposes. On the wider issue of the Statement of Licensing Policy (about which you wrote to, I think, all councillors a week or so ago), I understand that the legislation is about to change substantially both in respect of liquor licensing and in respect of live music.

It seems appropriate to me therefore that LDC should clearly have regard to what happens (or is likely to happen) to legislation over the next few months. In a practical sense that would perhaps involve proceeding with a short-term formal renewal, but being prepared to review again in 12 months time or less. I do not support a further three-year policy period.
