#### 162 Minutes

#### 163 Apologies for Absence/Declaration of Substitute Members

Apologies for absence had been received from Councillors S Catlin and V lent. Councillor Murray declared that she was acting as substitute for Councillor Catlin for the duration of the Meeting.

#### 164 Declarations of Interest

# 166 LW/16/0841 - Peacehaven Police Station (and Adjacent Buildings) 264 - 268 South Coast Road, Peacehaven, East Sussex BN10 7PD

Christine Bowman, Sue Griffiths and Robert Brown spoke against the proposal. Alex King spoke for the proposal.

#### Resolved:

- **166.1** That the first line of Condition 8 on page 15 of planning application LW/16/0841 be amended to read *"Prior to first occupation of any of the approved flats, details of the layout..."* instead of *"No development shall take place until details of the layout..."*;
- **166.2** That a landscaping condition be added to planning application LW/16/0841; and
- **166.3** That planning application LW/16/0841 for demolition of existing buildings and redevelopment to form 31 one and two bedroom sheltered apartments for the elderly including communal facilities, access, car parking and landscaping be approved, subject to:

Specialist (Planning) A. Completion of a S106 Agreement, to secure

(1) Occupancy of flats restricted to a person of 60 years of age or over, together with the spouse/partner of such person (provided the spouse/partner is of 55 years of age or older);

(2) A financial contribution of £300,000 (subject to inflation/indexation) towards the provision of affordable housing

elsewhere in Peacehaven, the payment being due prior to the commencement of development;

(3) Off-site highway works, including the footway along the southern side of the adjacent link road widened to 2m, with dropped kerbs and tactile paving as appropriate.

# 167 LW/16/0775 - East Sussex Gliding Club, Kitsons Field, The Broyle, Ringmer, East Sussex, BN8 5AP

Councillor John Kay spoke on behalf of Ringmer Parish Council. Mr John Deane and Michelle Larkin spoke against the proposal. Katherine Luxton spoke for the proposal.

#### Resolved:

**167.1** That planning application LW/16/0775 for the raising of ground level to create two safe landing strips for gliders with new site drainage be refused.

#### Reason for decision:

"There are not considered to be any overriding benefits of the proposed works that would outweigh the harm to the living conditions of residents living near the access routes to the site that would be caused as a result of noise and disturbance associated with the large number of vehicle movements that the works would generate. Consequently the application fails to comply with Policy WNP8b of the ESCC Waste and Minerals Plan 2013, Policy ST3 of the Lewes District Local Plan and Policy CP11 of the Joint Core Strategy."

#### 168 LW/17/0064 - Street Record, The Holt, Seaford, East Sussex

#### Resolved:

**168.1** That planning application LW/17/0064 for outline application for the erection of a dwellinghouse on land at the junction of The Holt and North Way be approved, subject to the conditions set out in the Report.
