Resolved:

124.1 That full planning application LW/17/0226 for the development of 143 dwellings (55 affordable), outline planning application for up to 307 dwellings (125 affordable), vehicular, pedestrian and cycle access, internal site roads, parking and public open space, including extension to Peacehaven Centenary Park, and landscaping, all matters other than access reserved (amended plans to show increase in depth of property type 67 by 1 metre and addendum to transport assessment), be deferred until the necessary information is made available to the Council in consideration of the report.

Reason for decision:

To allow for further clarity to the Committee on the Highways improvements proposed to be secured as part of the application.
