139 Minutes

140 Apologies for Absence/Declaration of Substitute Members

An apology for absence had been received from Councillor V lent. Councillor Carter declared that she was acting as substitute for Councillor lent for the duration of the meeting.

141 Declarations of Interest

Councillor Catlin declared his non-prejudicial interest in Agenda Item 9 (Planning Application SDNP/17/05815/House) as he was a member of Lewes Town Council.

Councillor Wallraven declared her non-prejudicial interest in Agenda Item 6 (Planning Application LW/17/0929) as she was a member of Seaford Town Council's Planning Committee.

Councillor Wallraven declared her personal and prejudicial interest in Agenda Item 7 (Planning Application LW/17/0896) as she knew the developer.

Planning Applications OUTSIDE the South Downs National Park

143 LW/17/0929 - Avondale Hotel, 4 - 5 Avondale Road, Seaford, East Sussex, BN25 1RJ

Mr Moore spoke for the proposal. Councillor Tony Nicholson spoke against the proposal in his capacity as an adjacent Lewes District Ward Councillor.

Resolved:

1. That planning application LW/17/0929 for change of use from hotel (Use Class C1) to an 18 bedroom House in Multiple Occupation (HMO) (Sui Generis) with a maximum of 30 residents be approved, subject to the conditions set out in the report and supplementary report, and a condition requiring compliance with the HMO Management Plan.

(Note: Cllr Wallraven declared her non-prejudicial interest in this item as she was a member of Seaford Town Council's Planning Committee. She therefore took part in the consideration, discussion and voting thereon.)

144 LW/17/0896 - 26 Hindover Road, Seaford, East Sussex, BN25 3NT

Mr Start spoke against the proposal. Roy McColl, Michael Greve and Julie Highman spoke for the proposal.

Resolved:

1. That planning application LW/17/0896 for conversion of existing two storey garage and sun lounge to create a self-contained 1-bed dwelling and construction of a vehicular access and off-street car parking space

be approved, subject to the conditions set out in the report and a requirement for a planting scheme on the frontage.

(Note: Councillor Wallraven declared her personal and prejudicial interest in this item as she knew the developer and therefore, left the room for the duration of this item and took no part in consideration, discussion and voting thereon).

145 LW/17/0593 - Asylum Wood Greenhill Way Haywards Heath West Sussex

Resolved:

1. That planning application LW/17/0593 for development of up to 375 new homes, a 2 form entry primary school with Early Years provision, a new burial ground, allotments, Country Park, car parking, 'Green Way', new vehicular accesses and associated parking and landscaping be deferred.

Planning Applications WITHIN the South Downs National Park

146 SDNP/17/05815/House – 16 St Annes Crescent, Lewes, East Sussex, BN7 1SB

Michael Meaney spoke against the proposal. Councillor Susan Murray spoke in her capacity as a Lewes District Ward Councillor.

Resolved:

1. That planning application SDNP/17/05815/FUL for increase in the length of the existing rear extension, addition of a second storey over, installation of a bike shed and a wooden gate in front garden and internal alterations be approved, subject to the conditions set out in the report.

(Note: Cllr Catlin declared his non-prejudicial interest in this item as he was a member of Lewes Town Council. He therefore took part in the consideration, discussion and voting thereon.)

147 SDNP/17/00071/FUL – Sussex Police Headquarters, Church Lane, South Malling, Lewes, BN7 2DZ

Resolved:

- That planning application SDNP/17/000071/FUL for demolition and partial demolition of 4 existing buildings and provision of additional car parking spaces be approved, subject to the conditions set out in the report, a Section 106 Agreement and the conditions set out below. The Committee added an informative.
- In view of the nature of the application and the increase in parking on the site the applicant should make provision for electric vehicle charging points across the site; and

2) The Planning Committee requested information from the applicant as to why other forms of parking provision, such as a multi storey car park which would significantly increase capacity, wasn't being put forward or considered.
