"The sale of Trust land, as detailed in Report No 35/15, be considered as an option, with a view to being a potential funding source for changing room improvements, and that the Officers be authorised to:

- Give public notice of the proposed disposal, inviting the making of representations, in accordance with section 121 Charities Act 2011
- Obtain advice from a qualified surveyor in order to comply with section 119 Charities Act
- Delegate the decision to dispose of the land to Officers, subject to taking

into consideration:

- any representations about the proposed disposal made within the time specified in the public notice;
- the advice obtained from the qualified surveyor; and 0
- any environmental and financial appraisals".

With the agreement of the Trustees and of his seconder, the Chair of the Council agreed to the revision of his motion to read:

"The sale of Trust land, as detailed in Report No 35/15, be considered as an option, with a view to being a potential funding source for changing room improvements, and that the Officers be authorised to:
