21 Minutes of the meeting held on 20 March 2017.

The minutes of the meeting held on 20 March 2017 were submitted and approved and the Chair was authorised to sign them as an accurate record.

22 Apologies for absence.

An apology for absence was reported from Councillor Robinson.

23 Declarations of Disclosable Pecuniary Interests (DPIs) by members as required under Section 31 of the Localism Act and of other interests as required by the Code of Conduct.

Councillor Tester declared an interest in agenda item 7 Hackney Carriage and Private Hire Penalty Points Scheme, as he felt he had predetermined his decision on this item. Councillor Tester withdrew from the room whilst this item was considered and did not vote thereon.

24 Hackney Carriage and Private Hire Penalty Points Scheme.

The Committee considered the report of the Functional Lead – Quality Environment seeking approval for the introduction of a Penalty Points scheme for all Hackney Carriage and Private Hire Drivers; Private Hire Operators and licensed vehicle owners to operate from 1 May 2018.

It was proposed to implement a penalty points scheme to improve the levels of compliance within the trade and subsequently improve the standards, safety and protection of the travelling public. The proposed penalty Points scheme was attached at appendix 1 to the report. It was designed to record misdemeanours and act as a record of a driver's behaviour and conduct so as to ascertain whether they remain fit and proper to hold the relevant licence.

At the General Licensing committee on 9 January 2017, Members were advised that the proposed scheme would be subject to a three month consultation period and would be open to the trade and members of the public. It was suggested that the scheme be directed to the Disability Involvement Group as part of the consultation. At that meeting, the committee requested that the report be bought back to a future meeting

following the consultation process which commenced on the 1 February 2017 and closed on 1 May 2017.

The Council received five responses, one of which represented 77 drivers from Eastbourne and County Taxis Ltd. Full details of the feedback were included at appendix 3 and 4 and summarised on pages 5 and 6 of the report.

As a result of the consultation there were two proposed Schemes attached at appendix 1 and 2 of the report. A third option to produce an Enforcement Framework scheme was also suggested with the detail needing further development should this be the preferred option of the committee.

Jay Virgo addressed the committee stating that sufficient sanctions were in place for the trade and in accordance with natural justice. Mr Virgo queried the legality of the introduction of a Penalty Points scheme over and above that which exists.

The Committee discussed the options outlined within the report and, whilst they acknowledged similar schemes existed across East Sussex, they agreed a Penalty Points scheme was not required in Eastbourne.

NB: Councillor Tester withdrew from the room whilst this item was considered.

1. Introduction

1.1 The Council sets conditions that are attached to either drivers or vehicle licences. There is a current condition on the Hackney Carriage Vehicle Licence Conditions that states "No signs, notices, advertisements, plates, marks, numbers, letters, figures, symbols, emblems or devices whatsoever shall be displayed on, in or from the vehicle except as may be required by any statutory provision (including byelaws) or required or permitted by these conditions". The current Hackney carriage conditions are included as **Appendix 1**.

1.2 Private Hire Conditions already permit advertisements with the permission of the council.

2.1 **Background Information**

- A letter was sent to the Licensing team signed by 9 Hackney Carriage proprietors requesting the change in condition to allow advertising on their vehicles. A copy of the letter is included in **Appendix 2**.
- 2.3 The trade have given the following reasons for this request in their letter:

'It would provide much needed extra income in these difficult times, and if approved, give the opportunity for interested local firms to advertise with local drivers.'

2.4 Members are asked to restrict advertising to only licensed vehicles displaying the full council livery for hackney carriage so that the public can be confident that they are using a legitimate vehicle. The trade have provided examples of how the advertising may look also in **Appendix2**.

3 Proposal

- 3.1 The Committee is asked to consider the proposal and determine whether advertising may be permitted on Eastbourne hackney carriage vehicles. The Committee should decide to either;
 - 1) Refuse this request
 - 2) Grant this request with appropriate guidance for advertising on hackney carriages as per Appendix 3

4 Advertising Guidance

4.1 Should the Committee be minded to grant the request for advertising on the offside and nearside of the rear of Hackney Carriages it is necessary to have standards applied to these to uphold decency and ensure they comply with the law. The advertising standards guidance is attached as **Appendix 3** to this report.

LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976

1. COLOUR OF VEHICLE

All vehicles brought into the Trade must have white paintwork.

Exemptions to 1.

- custom built cars
- limousines
- vehicles used exclusively for weddings and funerals

2. MAINTENANCE OF VEHICLE

The vehicle and all its fittings and equipment shall at all times when the vehicle is in use or available for hire be kept in an efficient, safe, tidy and clean condition and all relevant statutory requirements including in particular those contained in Motor Vehicles (Construction and Use Regulations) shall be fully complied with.

3. ALTERATION OF VEHICLE

No material alteration or change in the specification, design, condition or appearance of the vehicle shall be made without the approval of the Council at any time while the licence is in force.

4. CCTV EQUIPMENT

CCTV, including digital stills equipment may be installed in this licence vehicle subject to the following provisions:-

- 1. Approval in writing must be obtained from the Council before CCTV equipment is installed and used in the vehicle;
- 2. CCTV equipment shall be of a specification approved by the Council; The equipment shall be installed, operated and maintained to the satisfaction of the Council;
- 3. Any material recorded on the equipment shall be used only as evidence in court proceedings or to aid investigation of a crime or to confirm or rebut complaints made against a driver;

- 4. Material captured by the system shall be accessible only to the Police, specifically authorised Council officers or other persons authorised by the Council;
- 5. Recorded material must be made available upon demand to the Police and a duly authorised officer of the Council;
- 6. Notices indicating that the CCTV system is in operation in the vehicle shall be clearly displayed on passenger windows visible from the outside and in the interior of the vehicle. The notices shall state "CCTV OPERATES IN THIS VEHICLE" Such notices shall not be displayed unless the system is in use;
- 7. Each system must be registered with the office of the Data Protection Registrar with proof of registration supplied to the Council.

5. SAFETY EQUIPMENT

There shall be provided and maintained in the vehicle at all times when it is in use or available for hire, a suitable and efficient fire extinguisher and a suitable first aid kit containing appropriate first aid dressings and appliances, such equipment to be carried in such a position as may from time to time be approved by the Council so as to be readily visible and available for immediate use in an emergency.

6. INTERIOR MARKINGS

The proprietor shall cause to be clearly marked and maintained inside the vehicle in such a position as to be visible at all times to persons conveyed therein the number of this licence and the number of passengers prescribed in this licence.

7. SIGNS, NOTICES, ETC.

- (1) No signs, notices, advertisements, plates, marks, numbers, letters, figures, symbols, emblems or devices whatsoever shall be displayed on, in or from the vehicle except as may be required by any statutory provision (including byelaws) or required or permitted by these conditions, provided however that this condition shall not apply:-
 - (i) To any indication on a taxi meter fitted to the vehicle or to a sign which:
 - (a) is displayed in, on or from the vehicle while it is stationary;

- (b) contains no words or numbers other than the name and address of the operator of the vehicle or the name under which he carries on his business and its address and, in either case, the name of the passenger or passengers to be carried in the vehicle; and
- (c) is displayed in pursuance of a prior arrangement made for the carriage of a passenger or passengers named in the sign.
- (ii) to the corporate door sign which shall be displayed on both front doors

Exemptions to (1)(ii)

- custom built cars
- limousines
- vehicles used exclusively for weddings and Funerals
- (iii) to optional door signs of a design approved by the Council for display on the rear door panels of the vehicles, when not more than one sign shall be displayed on each side of the vehicle. The proprietor shall obtain the consent of the Council for such signs before they are first displayed.
- (2) The proprietor shall cause to be affixed and maintained to the roof of the vehicle at all times that the vehicle is in use as a taxi, the authorised sign for taxis licensed by the Council. The sign shall comprise a yellow base material with attached blue front panel bearing the words EASTBOURNE TAXI in yellow. The rear panel of the sign shall bear the word TAXI or if the proprietor chooses, the telephone number of the taxi business. The word TAXI or telephone number of the taxi business on the rear panel shall be in red on a black background in Helvetica Bold font style. The letters of the word EASTBOURNE shall be 2.5cm high and 2cm wide. The letters of the word TAXI shall be 7cm high and 8.5cm wide. The digits of the telephone number on the rear of the sign shall be 8cm high and 5cm wide.

The sign shall be illuminated and have a green light on top capable of being switched on to indicate the vehicle is for hire.

The sign shall be displayed transversely on the roof of the vehicle and may not exceed 46cm in width and 17cm in height of a type approved by the Council.

Fairway, Metrocab and similar purpose-made taxis with built-in signs are exempt from the above.

Additional exemptions to 6(2) are:-

- custom built cars
- limousines
- vehicles used exclusively for weddings and funerals

8. TAXIMETERS

Taximeters fitted to hackney carriages shall be fully date and time operated calendar meters with the manual override disabled. The taximeters shall be British Standards Institute and Public Carriage Office approved. This condition shall apply from 1st June 2002.

9. CONVICTIONS

The proprietor shall within seven days disclose to the Council in writing details of any conviction imposed on him (or, if the proprietor is a company or partnership, on any of the directors or partners) during the period of the licence.

10. APPEALS

Any person aggrieved by these conditions may appeal to the magistrates' court within 21 days of being notified of the Council's requirements. There is a further right of appeal to the Crown Court against a decision of the magistrates.

Advertising in Brighton Taxi

ADVERTISING IN EASTBOURNE HACKNEY CARRIAGES

No advertisement is permitted on or in a taxi unless it meets the following requirements.

- 1. The advertising agency name should be carried on the advertisement.
- 2. The advertisement(s) on each vehicle should not advertise more than one company, product, service, or location although a sponsor's details are permissible.
- 3. Advertisements will not be approved if, in the Senior Specialist Advisors reasonable opinion, the advertisement falls within any of the following categories:

The advertisement ...

- does not comply with the law or incites someone to break the law.
- does not comply with the British Code of Advertising, Sales Promotion and Direct Marketing.
- is likely to cause widespread or serious offence to members of the public on account of the nature of the product or service being advertised, the wording or design of the advertisement or by way of inference.
- depicts men, women or children in a sexual manner or displays nude or semi-nude figures in an overtly sexual context.
- depicts or refers to indecency or obscenity or uses obscene or distasteful language.
- relates to lap-dancing, 'gentlemen's clubs', escort agencies or massage parlours.
- depicts direct or immediate violence to anyone shown in the advertisement.
- condones or provokes anti-social behaviour.
- relates to films which have not been granted permission for public exhibition or which do not show the British Board of Film Classification certificate.
- contains images or messages which relate to matters of public controversy and sensitivity.
- relates to a political party or parties or a political cause.

Proprietors and drivers should seek prior approval to display advertisements that comply with the above.

If the Senior Specialist Advisor considers an advertisement may not comply with these guidelines they may request a copy of the advertisement in either hard copy or electronic form, along with other reasonable information including details of the relevant advertising agency that prepared the advertisement.

If the Senior Specialist Advisor considers that the advertisement does not comply with these guidelines, s/he may propose or invite reasonable variations to the advertisement or require the advertisement to be removed. In the latter case the Senior Specialist Advisor will provide written reasons for the decision.

1 Introduction

- 1.1 Under section 65(1) of the Local Government (Miscellaneous Provisions) Act 1976, the Local Authority has the power to set the maximum fares for the hire of a Hackney Carriage vehicle.
- 1.2 The existing Hackney Carriage Fares were approved by the General Licensing Committee in 2009.

2 Background

2.1 The last consultation of the fare structure took place in 2009 and the General

Licensing Committee formally adopted the current fares for Hackney Carriages within the Borough.

- 2.2 The current fares have been in place for 9 years and the trade has requested a review of the current fare structure. There are currently 113 licensed hackney carriages that are allowed to ply for hire in Eastbourne. Fares charged by hackney carriages cannot be more than the fare set by Eastbourne Borough Council. The council do not set the fares for private hire vehicles.
- 2.3 Following informal requests made by some Hackney Carriage proprietors and discussions at the Taxi Forum, all Hackney Carriage proprietors were written to on 1st February 2018 and requested that they contact the Licensing team to advise if they are in favour of a fare increase. It was made clear that should more than 50 % of the trade feel an increase is appropriate then a report would be presented to General Licensing Committee. A copy of this letter is included at **Appendix 1.** The letter also requested proposals for a new fare structure.
- The Licensing Team received 86 positive responses from Hackney Carriage Proprietors which equates to 76% of their total number. One Proprietor proposed an alternative to the current fares and that proposal is included as **Appendix 2**. On the face of it that appears to be the proposal of a sole Proprietor, rather than being an agreed proposal made on behalf of the majority of the Taxi trade.

3 The proposal

- 3.1 A proposal for a change in fares has been received from a member of the trade who state it is reasonable to reflect the additional cost incurred by proprietors including increase in fuel costs, repairs and inflation.
- 3.2 The current fare card is included as **Appendix 3** but is reproduced in Table 1 along with the proposal from the trade in Table 2 for easy comparison with details of the proposed changes in bold.

- The 'Table of Fares for England' published by the Private Hire and Taxi Monthly published August 2018 shows that based on a two mile fare (the fares national tariff 1) varies from £10.60 (London Heathrow) to £3.50 (South Kesteven). Eastbourne currently at £5.70 which ranks Eastbourne at 207 of 366 councils. Permission has been obtained to reproduce the PHTM Tables of Fares and is reproduced as **Appendix 4**.
- Other East Sussex Authorities are shown on the Table of Fares for England as follows.

- 3.5 The proposed fare card increases the meter at start and distances up to 5 miles fares significantly. The proposal would place Eastbourne with a ranking of joint 3rd at £8.40 in England and would be more than London at £7.80 ranked 5th.
- It can be seen that although the proposal would significantly benefit proprietors the public would be disadvantaged compared to other authorities in East Sussex. However it is acknowledged that the current fares have not been reviewed for the past 9 years and fall below the average for East Sussex.
- 3.7 Options, 1. The Committee agree the proposal to increase the fares, as set out in Table 2 and Appendix 2, and recommend the same to the Cabinet portfolio holder for place services, along with the recommendation to delegate the Senior Specialist Advisor to comply with the statutory process of publishing the proposal, or 2. That the Committee reject the proposed increased fares, as set out in Table 2 and Appendix 2, and agree to delegate the Senior Specialist Advisor to undertake a 6 week consultation exercise with the Taxi trade to draft a proposal on increasing Hackney Carriage fares for Members to consider at a future meeting.

4 Financial appraisal

This consultation has no direct financial implications. Any subsequent cost of advertising the amended 'Table of Fares' in a local newspaper will be taken from funds already reserved in the Taxi Licensing Budget.

5 Legal implications

- The Local Government (Miscellaneous Provisions) Act 1976 ("the 1976 Act") allows the Council to set the maximum costs and fares for hackney carriages. In this context the "Council" means the Executive by virtue of The Local Authorities (Functions and Responsibilities) Regulations 2000 (as amended).
- Under Section 65 (2) of the 1976 Act when the Council proposes to vary the hackney carriage fares it must publish a notice in a local newspaper stating the proposed new fares and give at least 14 days for any objections to be made. If there are objections, the Council must consider them before deciding whether to confirm or modify the proposed fares. If there are no objections the new fares can be brought into force at the end of the objection period. If the Council varies the proposed fares following any objections made within this period it then sets a second date, which cannot be more than two months after the first date specified, when the new fares comes into force."

5.3 This Report was considered by the Councils Legal section on 10 September 2018 (Iken 7653-MW).

1 Introduction

- 1.1 Currently Eastbourne Borough Council does not have comprehensive Guidance relating to Hackney Carriage and Private Hire Vehicles although it does have licence conditions and byelaws and guidelines relating to the relevance of convictions etc. that have been in place for a number of years.
- 1.2 It is important that the taxi trade and relevant stakeholders are consulted on any changes to existing conditions etc. before it is implemented.

2 Background

2.1 The current landscape for hackney carriage and private hire licensing has changed significantly over recent years with smart phone apps changing the way

vehicles can be booked, the change in the law allowing cross border subcontracting of jobs and sexual exploitation incidents involving the taxi trade in other parts of the country.

- The Eastbourne Disability Involvement Group have written to the General Licensing Committee expressing their concern that at the current time they feel the current taxi provision does not meet the needs of disabled passengers. These concerns can be addressed in the proposed new Guidance which will benefit both the trade and the Council. This is produced as **Appendix 1**.
- 2.3 It is appropriate that the Guidance is put in place in light of these issues and brought up to date to ensure the Council protects the safety and welfare of the public.

3 Financial appraisal

3.1 There is no significant cost identified within this report. There will be minor costs associated with administering the consultation.

4 Legal implications

- 4.1 There is no statutory requirement for the licensing authority to adopt any Guidance in relation to hackney carriages or private hire licences but it is considered best practice to do so as it informs and guides decision makers and assists with consistent decision making. However, the Guidance must not fetter on decision making as each case must continue to be judged on its own merits.
- The Council when drafting the new Guidance should take into consideration the duties and powers imposed on it, and those imposed on hackney carriage drivers, private hire drivers and operators as contained within Chapter 1, Part 12 of the Equality Act 2010.

5 Risk management implications

5.1 It is important that these changes are considered to ensure the safety of the public.

1. Overall compliance with the Equality Act 2010

We welcome the Council's overall approach to equality, as outlined in the Equality and Fairness Policy and the implementation of the Equality Objectives and Action Plan. We note the following as being of specific relevance:

'To promote equality and fairness and eliminate discrimination, ensuring fair access to services and opportunities; and to comply with the Council's general and specific duties under the Equality Act 2010'.¹

Objective 3: 'We will promote fairness and accessibility'.2

Equality and Fairness Policy- 'The Council is committed to involving disabled people at an early stage in decisions that affect them and will continue to apply the principles of the government's 'Disability Confident Committed Employer' scheme for recruitment. The Council is also committed to minimizing barriers restricting access to our premises, facilities, services, democratic processes and employment. To this end the Council will continue to engage with local groups about specific areas that matter to them and those that matter to the Council'.³

2. Sections 165-180 of the Equality Act which specify the accessibility regulations for wheelchair users and users of assistance dogs that came into force on 6 April 2017

From 6 April 2017, drivers of taxis and PHVs designated by each licensing authority as being wheelchair accessible were required by law to comply with the requirements of Sections 165 onwards of the Equality Act 2010, unless they have been issued with an exemption certificate on prescribed and specific grounds.

The law from April 2017 introduced duties for each local Licensing Authority to:

- Designate vehicles as wheelchair accessible
- Communicate new legal requirements to Taxi and PHV drivers
- Handle exemption applications from drivers who cannot meet the requirements due to medical reasons and:
- Enforce the requirements
- 3. Section 165 of the Act in law from April 2017 set out the duties placed on drivers of designated wheelchair accessible taxis and PHVs, as follows:

'To carry the passenger while in the wheelchair; not to make any additional charge for doing so; if the passenger chooses to sit in a passenger seat to carry the wheelchair; to take such steps as are necessary to ensure that the passenger is carried in safety and reasonable comfort. To give the passenger such mobility assistance as is reasonably required. Also to enable the passenger to get into or out of the vehicle; If the passenger wishes to remain in the wheelchair, to enable the passenger to get into and out of the vehicle while in the wheelchair. To load the passenger's luggage into or out of the vehicle; If the passenger does not wish to remain in the wheelchair, to load the wheelchair into or out of the vehicle. Once the duties are commenced, it will be an offence for the driver (unless exempt) of a taxi or PHV which is on the licensing authority's designated list to fail to comply with them'.⁴

4. Assistance Dogs for people with mobility and/or sensory impairments

'Section 168 of the Equality Act as from April 2017 imposes duties on the driver of a taxi which has been hired by or for a disabled person who is accompanied by an assistance dog, or by another person who wishes to be accompanied by a disabled person with an assistance dog, to carry the disabled person's dog and allow it to remain with that person and not make any additional charge for doing so'.⁵ The law change on 6 April 2017 introduced legal sanctions in so far that a person guilty of an offence in respect of the above sections is liable on summary conviction to a fine not exceeding level 3 on the standard scale.

5. Our Recommendations

- 1. EBC to commit to the principles and vision of the Government's Inclusive Transport Strategy, published on 25 July 2018. The Strategy recommends that: 'authorities not only use the powers available to them to ensure that taxi and PHV services not only comply with the legal requirements but that these services meet the needs of passengers more consistently'.⁶
- 2. Develop policies and procedures to achieve compliance with the Equality Act 2010 sections 165 onwards relating to Taxis that came into force on 6 April 2017.
- 3. Change the existing policy of licensing ONLY side loading WAVs and license a flexible, accessible fleet. Currently the WAVS most suitable for carrying powered wheelchairs (including manual or powered wheelchairs which are not deemed as 'standard reference') are not available to wheelchair users. A more flexible approach is needed to facilitate the availability of other types of side loading vehicles other than just 'London style' cabs and also to increase the choice of rear loading WAVS.
- **4.** Ensure disabled people have proper and effective access to full information about each designated WAV. Maintain a list that is updated with contact details and information. The statutory guidance states that: 'it would also be helpful to include information about the size and weight of a wheelchair that can be accommodated, and whether wheelchairs that are larger than a "reference wheelchair" can be accommodated'.⁷

5. Adopt a proactive equality and fairness policy for taxi users (such as the Brighton Accessibility Policy for wheelchair users, people with visual, hearing impairments and learning disabilities). The statutory guidance states: 'We encourage LAs to provide drivers of taxis and PHVs who are not exempt from the duties with clear guidance on their duties with respect to the carriage of passengers in wheelchairs, either as part of existing driver-facing guidance, or as supplementary communication'.⁸ To strengthen this further we would like to see a policy that includes mandatory training so drivers and owners better understand their responsibilities under current legislation.

- **6.** Take action to tackle the exorbitant charges that the Eastbourne area PHVs often apply to the carriage of wheelchair users, compared to the same journeys that would be undertaken by non- mobility impaired customers. The guidance recommends that each 'licensing authority guidance for drivers is updated to make clear when a meter can and cannot be left running'9.
- 7. Introduce procedures related to: prescribed Exemptions for Taxi operators, appeals process in respect of Exemptions, a complaints and enforcement mechanism for both local Taxi operators designated as WAVS and a complaints process for disabled people facing discrimination or less favourable treatment.
- 8. Actively work towards an increase in the choice and availability of WAVS in Eastbourne as there is a current scarcity of WAVS available during school hours, as well as during evenings and weekends. Examine an approach that requires larger operators (e.g. over 10 vehicles) to maintain a minimum percentage of WAVS in their fleets. Ensure all transferred, licensed Taxi plates are designated as wheelchair accessible.
- **9.** Work with local disability groups who will undertake a mystery shopping exercises with disabled Taxi users who are living with the full range of mobility, sensory and learning impairments, in order to ensure policies are being effective.
- **10.** Promote communication and awareness of the new policies with local disability groups and the Council's Disability Involvement Group: inviting feedback from local disabled people, and follow up any issues that arise.
- **11.** Strengthen the current complaints mechanism to ensure that complaints are responded to in a timely and appropriate fashion. Adopt a zero tolerance approach to any evidence of unlawful discrimination taking place. Investigate complaints of discrimination or less favourable treatment and take appropriate enforcement action.

In conclusion

Eastbourne Borough Council needs to develop, implement and monitor a proactive accessibility policy that will lead to a greater choice of types of WAVs that are licensed, thus ensuring both availability and increased choice for wheelchair users. Of the 15,000 NHS wheelchair prescribed users in East Sussex alone, a high proportion of these NHS Page | 5 wheelchair users have been prescribed powered wheelchairs, due to their clinical needs. It is simply not an option for many wheelchair users to transfer out of their wheelchairs and/or use a manual wheelchair for travel in taxis. The demographic of people living longer but with more complex conditions delineates the importance of addressing taxi access and availability for local disabled people. The current lack of choice and restricted availability of WAVS and accessible, affordable PHVs also adversely affects our tourist trade, as well as local disabled citizens.
