## 22 Minutes

The minutes of the meeting held on 6 June 2018 were submitted and approved, and the Chair was authorised to sign them as a correct record.

# 23 Apologies for absence/Declaration of substitute members

An apology for absence had been received from Councillor Stephen Catlin. Councillor Neave declared that he was acting as substitute for Councillor Catlin for the duration of the meeting.

## 24 Declarations of interest

Councillor Neave declared a personal and prejudicial interest in agenda item 7 (planning application LW/18/0060) as he was a Peacehaven Town Councillor and the council had business dealings with the developer.

The Chair had agreed, in accordance with Section 100B(4)(b) of the Local Government Act 1972, that the supplementary report to the Planning Applications Committee be considered as a matter of urgency in order that the Committee could take its decisions based on the most recent information which was available (a copy of which is published to the website).

Planning applications outside the South Downs National Park

# 27 LW/18/0331 - Land north of Chapters, Bishops Lane, Ringmer, East Sussex

Councillor John Kay spoke on behalf of Ringmer Parish Council. David Terry and Sy Morse-Brown spoke against the proposal. Simon Packer and Paul Matcham spoke for the proposal. Councillor Johnny Denis spoke in his capacity as a Lewes District Ward Councillor.

### Resolved:

That planning application LW/18/0331 for approval of the reserved matters following outline permission LW/14/0127 (allowed on appeal) for the erection of up to 110 dwellings relating to appearance, landscaping, layout and scale (resubmission of application LW/17/0045) is deferred to the Head of Planning for approval subject to the following amendments to conditions and additional changes sought by Members:

- Amendments to the condition to protect the historic hedge and mention specifically the three sections of said hedge. Informative to be added "in consultation with Ringmer Parish Council".
- The position of the electricity sub-station is incorporated into condition 6.
- Norlington Court is specifically identified in condition 9.
- That the amendments to the affordable housing mix are approved in writing by the Head of Planning pursuant to the existing S106 Agreement associated with the outline consent.
- That the LEAP is removed from the application site and a payment sought in lieu.
- It was agreed that the list of revised drawings presented at the Committee in the urgent item Supplementary Report were those defining the application and not those on the officer's report.
- It was agreed that condition 8 d would be strengthened to make clear that the three sections of hedge which traversed the site were all included in the hedgerows to be protected as they formed a wildlife corridor.

In the event that these matters cannot be resolved to the satisfaction of the Head of Planning, that the application be taken back for further consideration by the Planning Applications Committee.

# 28 LW/18/0060 - 179 South Coast Road, Peacehaven, East Sussex, BN10 8NR

Kingsley Roger-Jones spoke for the proposal. Councillor Nigel Enever spoke in his capacity as a Lewes District Ward Councillor.

## Resolved:

That planning application LW/18/0060 for demolition of existing property and erection of 3 storey block of flats comprising three x 2 bedroomed flats and two x 1 bedroomed flats be approved, subject to the conditions set out in the report and supplementary report (as amended at the Committee to include details of the colour scheme of the external materials under condition 1 and requiring vehicle charging points under a new condition 9).

(Note: Councillor Neave declared a personal and prejudicial interest in this item as he was a Peacehaven Town Councillor and Peacehaven Town Council had business dealings with the developer. He therefore left the room for the duration of this item and took no part in consideration, discussion and voting thereon.)

# 29 LW/18/0246 - 4 Strawlands, Plumpton Green, East Sussex, BN7 3DB

## Resolved:

That planning application LW/18/0246 or erection of one x three bedroom detached dwelling be approved, subject to the conditions set out in the report.

# 30 LW/18/0234 - 2 Ambleside Avenue, Telscombe Cliffs, East Sussex, BN10 7LS

# 31 LW/18/0297 - Land adjacent to 39 Ashington Gardens, Peacehaven, East Sussex

## Resolved:

That planning application LW/18/0297 for three new 1 bedroom bungalows with car parking each plus 1 additional visitor parking space be approved, subject to the conditions set out in the report and supplementary report.
