As long time residents of Gilbert Road we would like to add our support to the proposed licensing of Seaside Rec.

It's important to encourage better use of this valuable open space and it can only improve as more people use the area, which will in it's turn discourage antisocial behaviour. The drinking and drug dealing is going on now and has nothing to do with whether there is a licence or not.

People seem to think that if there is an alcohol licence it cannot be a family friendly event. We often visit the Lammas fair on the Western lawns which has a beer tent and that has proved successful, although this is a daytime event. But then most family events would take place during the day.
