Recommendation: To note the report.

1.0 <u>Introduction</u>

- 1.1 This report deals with the elections and referendum held on Thursday 5 May 2011. Details of the results and of the candidates elected are given together with other related information.
- 1.2 These elections were held for all of the Council seats. Three in each of the 9 wards. In addition a national referendum was held in respect of a proposed change to the voting system for parliamentary elections. Voters were asked to say yes or no to the question:

At present, the UK uses the 'first past the post' system to elect MPs to the House of Commons. Should the 'alternative vote' system be used instead?

1.3 A total of 94 candidates stood for election representing 5 political parties (Conservative, Green, Labour, Liberal Democrats and UKIP). Only the Liberal Democrats and Conservatives fielded candidates in respect of all 27 vacancies, although all parties except UKIP had candidates in all 9 wards. In addition there was an independent candidate in Devonshire ward.

2.0 Results

- 2.1 A copy of the election results for the 9 Eastbourne wards is attached at **Appendix 1.**
- 2.2 The candidates elected and their terms of office (see note below) are as follows:-

Term of office. The term of office for all of the above named Councillors will expire on the 4th day after the ordinary day of election (i.e. the first Thursday in May) in the year 2015.

2.3 The share of all of the valid votes across the whole town was as follows:

3.0 Electoral Turnout Figures

The electorate for the borough council election was 73,094. Overall, the electoral turnout was 44.17%. Turnout by ward is shown in the appendix to this report. This ranged from 34.39% in Langney to 53.42% in Old Town. Previous year's turnout figures (by ward) going back to 2002 are available on request.

The AV referendum turnout figures are given above in 2.4. above.

4.0 Poll Cards

4.1 Poll cards were again printed in a larger format with additional information advising how to apply for a postal vote. The poll cards were despatched on 28 March, 4 weeks prior to election day.

5.0 Absent Voting

- The big increase in the numbers of people having postal votes has been maintained. The total number of postal votes sent out for these elections was 14,006. Postal voters comprised nearly a fifth (19%) of the electorate and of all the votes received nearly a third (32%) were received from postal voters.
- 5.2 All postal voters' signatures and dates of birth are now held on computer from information provided when application is made. The voting procedure requires postal voters to sign and give their date of birth when returning their vote. This requires signature recognition software to be linked to our electoral computer system. The whole process is very time consuming but we successfully achieved our objective in checking all returned postal votes including those handed in at polling stations in time for the count.

- The closing date for postal vote applications was 5pm Thursday 14 April. By late that evening we had completed the transfer of encrypted data to the printers. Our postal votes and ballot papers were printed and delivered to Royal Mail on the 19 April for despatch to voters. Daily opening sessions commenced on 26 April.
- The following table shows trends in postal voting in local elections since 2004:

- The total number of replacement postal voting ballot papers issued was 18. These were provided to people who had either not received their papers or had lost them 16 in total) or had spoilt them and needed replacements 2 in total). Proof of identity with photograph is generally required in these cases. The number of postal votes received after the close of poll and too late to be counted was 41 (as at midday Friday 13 May).
- 5.7 A total of 97 (local election) and 111 (referendum) proxy votes were granted. This compared with 95 in the 2009 combined European and county elections and 324 in the 2010 parliamentary election. This included one emergency proxy application which was allowed.

6.0 **Polling Stations**

6.1 36 polling stations were opened between the hours of 7.00 a.m. and 10.00 p.m. on the 5 May at 31 different venues. A total of 127 people were employed for the day to staff the stations.

- Four additional stations were operated on this occasion in order to comply with a direction from the Chief Counting Officer of the Electoral Commission which stipulated that no station should cater for more than 1,500 voters. This was despite the council having made satisfactory arrangements in previous years for catering for larger electorates.
- 6.3 A new polling station for voters in Sovereign ward polling district SVC was brought into use this year at the Sovereign Harbour Yacht Club. In St Anthony's Ward, Archery Youth Centre was used as the polling venue for voters in the SAC polling district as a consequence of the destruction of St Andrew's Church Hall by fire. Four other venues became 'double' stations in order to comply with the Electoral Commission directive. These were Shinewater Community Centre (Langney Ward district LGB), Greenfield Methodist Church Hall (Old Town district OTA), Roselands School (St Anthony's Ward districts SAA and SAB) and Langney Community Centre (St Anthony's Ward district SAD).

7.0 <u>Counting Arrangements</u>

- 7.1 The local election count took place in the Devonshire Park Halls (adjacent to the Winter Gardens). 108 counting staff were engaged for the purposes of counting the votes. The count commenced at 10.00 p.m. on the 5 May. Other Council staff assisted in the preparations and the count itself, including staff from Strategy and Democracy, Eastbourne Theatres, Town Hall facilities and support staff, press office, IT and Steria and the members of the Council's Corporate Management Team.
- 7.2 The initial verification stages (for both the local ballots and the referendum ballots) were completed by about 1am. At this stage the numbers of ballots in the boxes are reconciled with the numbers issued in polling stations and at the opening of the postal votes. After verification, the referendum ballots were secured and put away until the Friday afternoon count. The first local result was declared at 3am (Hampden Park Ward) and the last at 5am (Meads Ward).
- 7.3 The Council's website was updated directly from the counting hall and the results displayed on the website shortly after each result was declared.
- 7.4 In accordance with a national direction, the referendum count commenced at 4pm on Friday 6 May. The count was completed by about 6.30pm, however, the result was not declared until about 7pm due to the need to seek certification from the Regional Counting officer at Southampton.

8.0 <u>Joint purchasing arrangements</u>

8.1 Eastbourne Electoral Services has joined with their counterparts in the other East Sussex district councils to jointly procure their election printing and stationery requirements in order to achieve economies of scale and improved discounts. As part of this collaborative work, a single county-wide contract was let for the printing of ballot papers, poll cards and postal votes. This contract will also cover future elections up to 2012, after which the contract is due to be retendered.

9.0 De-briefing

9.1 As is now the usual practice, party election agents will be invited to a debrief meeting with the objective of improving upon the arrangements for future years. This will take place on Thursday 9 June 2011. It would be helpful if any Members who wish to raise any issues or make suggestions for the future could draw these to my attention or raise them direct with their party agent.

10.0 Conclusion

I would like to record my thanks to everyone who contributed to the election. As election day itself went so smoothly it could be easy to underestimate the amount of work that went into making it a success and noting the many months of planning, helping people to register and dealing with thousands of postal votes leading up to the big day. I am grateful to everyone who worked a long hard day on polling day with such enthusiasm and professionalism. Party agents commented to me that they wanted to give credit where it was due, not only on how well organised the whole process was, but also that staff were good humoured, helpful and always willing to chat. The confidence they gave them helped the count itself to progress smoothly and with a great deal of consensus. This was my second election as Returning Officer and I am delighted the involvement of all concerned ensured that all went well.

Town-wide turnout: 44.17%. (Electorate: 73,094. Voted: 32,286)

The last Borough Council elections were held on 3 May 2007 when the town-wide turnout was 42.26 %.
