### **Summary:**

This report deals with a review of the polling districts and polling places provided for elections that take place within the Borough of Eastbourne. The Council has a duty to undertake a full review at intervals of not less than 4 years.

The Council is expected to ensure that all electors in the constituency have reasonable facilities for voting as are practicable in the circumstances and that so far as is reasonable and practicable the polling places are accessible to those who are disabled.

A 12 week consultation was held ending on 29 October 2010. All representations received to the Council's proposals are set out in the report along with proposed responses and final recommendations.

Following this review, the revised polling arrangements will be implemented as from 1 December 2010.

### **Recommendations:**

- (1) That no change be made to existing polling district boundaries as shown on the maps accompanying the consultation document.
- (2) That the proposals for polling places be as described in appendix 1 to this report.
- (3) That the Electoral Services Manager, on behalf of the Returning Officer and Electoral Registration Officer, be authorised to implement the Council's decisions in respect of the review.

## 1.0 Introduction

- 1.1 The Council must regularly review the division of its area into polling districts and the places where electors are asked to vote. A full review of the whole borough must be undertaken at intervals of not less than 4 years.
- 1.2 The relevant legislation can be found in section 16 of the Electoral Administration Act 2006, the Representation of the People Act 1983 and the Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006. Guidance is also published by the Electoral Commission.
- 1.3 This matter is brought before full Council as decisions on matters in respect of polling district boundaries and polling places cannot be dealt with by a council's executive (i.e. the Cabinet) by virtue of The Local Authorities (Functions and Responsibilities) (England) Regulations 2000.
- 1.4 The Council's first full review under the legislation was carried out in late 2007 and approved by the Council in January 2008. Although the next full review is not due to be completed until the end of next year (2011) it has been decided that as there will be whole council elections for the Borough next May (and no scheduled elections for 2012) the review should be carried out a year earlier. A pattern will then be established for the future of having the 4-yearly review in the year before the borough elections.

# 2.0 Review process

- 2.1 As part of the review process the Council must:
  - Seek to ensure that all electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances;
  - Seek to ensure that so far as is reasonable and practicable the polling places are accessible to those who are disabled, and
  - When considering or reviewing the designation of a polling place, have regard to the accessibility needs of disabled persons.
- 2.2 The consultation period for this full review ran for 12 weeks between 20 August and 29 October 2010 in line with recognised best practice for conducting such consultations. Public notice of the review was published and information about the review made available on the Council's website. Any elector in the whole of the Eastbourne constituency (whether they live in the borough or not) was entitled to make representations.
- 2.3 The consultation document, together with maps of each ward showing polling district boundaries, can still be viewed on the Council's website at <a href="http://www.eastbourne.gov.uk/council/consultations/2010/polling-districts-and-polling-places-consultation/">http://www.eastbourne.gov.uk/council/consultations/2010/polling-districts-and-polling-places-consultation/</a>
- 2.4 As well as being supplied on request, the consultation document was sent to the local Member of Parliament, Borough and County Councillors, local political parties. It was also sent to the Eastbourne Disability Group (DIG)

as required under the regulations as persons having particular expertise in relation to access to premises or facilities for persons who have different forms of disability. The DIG is an umbrella group of local organisations that represents some 1,500 disabled people living in Eastbourne

## 3.0 Definitions

3.1 "Parliamentary constituency". This cannot be changed by the review. It is the division of the constituency into polling districts and places that is the subject of the review. It should be noted that only that part of the Eastbourne constituency that is within the Borough of Eastbourne that is being reviewed by the Council. The area of the constituency that lies outside the Borough (Willingdon, Jevington and Wannock) will be reviewed separately by Wealden District Council.

**"Polling district".** The area created by the division of a constituency or ward into smaller parts, within which a polling place can be determined which is convenient to the electors.

**"Polling place".** The building or area in which polling stations will be selected by the Returning Officer.

**"Polling station".** The actual area where the process of voting takes place. This must be located within the polling place and designated for the particular polling district. This function is the responsibility of the Returning Officer.

## 4.0 The proposals and comments received

- 4.1 An appendix to the consultation document set out details of current polling districts and polling places for each of the nine wards in the Borough of Eastbourne together with details of proposed changes. This appendix has been updated to indicate the proposals for which comments have been received and forms **appendix 1** to this report. **Appendix 2** comprises the full text of all comments received.
- 4.2 The following summarises the proposals and comments received together with any necessary observations on the comments:

### **Devonshire Ward**

No changes are proposed.

Comment: Councillor Wallis suggested changing the polling place for district DVD (which currently votes at The Archery) to the new community hall in Wartling Road. His reason is that the temporary loss of St Andrew's Church Hall St Anthony's will mean that electors in SAC will vote at The Archery and he is concerned in case there would be any confusion or delay in having 2 wards voting at the same venue. I am satisfied that the 2 polling places can be successfully located at The Archery. Each will be an entirely separate polling station and appropriate notices will be provided and staff on hand to assist voters as necessary. It is anticipated that once St Andrew's Hall is re-

built the "dual" use of The Archery will end. The hall in Wartling Road is a greater distance for the majority of residents as compared with The Archery.

# **Hampden Park Ward**

No changes are proposed.

Comment: Councillor Thompson is happy with current arrangements.

## **Langney Ward**

No changes are proposed.

#### **Meads Ward**

No changes are proposed.

#### **Old Town Ward**

No changes are proposed.

### **Ratton Ward**

No changes are proposed.

Comments: Councillor Goodall is happy with current arrangements. Councillor Belsey notes that the old church hall on the corner of Spring Close that was previously used as a polling place is still extant. This was replaced by the back room of the Red Lion pub some years ago when the hall went on the market. It is my understanding that the hall is not available for hire and as the current arrangements have proved to be satisfactory I can see no reason to seek any change in the arrangements.

### St Anthony's Ward

- 1. Changes proposed for polling places in districts SAA and SAB (move to Sun Coast Church, 3 Courtlands Road, instead of Roselands School).
- 2. Temporary change for polling place in district SAC (move to The Archery Youth Centre until St Andrew's Church Hall is rebuilt).

Comments: Roselands School have repeated their concerns at the use of the school.

The proposal to re-locate to the Sun Coast Church will be much welcomed by the head, governors and parents of the school. The church premises have level access, disability parking space, an entrance reception area and a large hall.

## **Sovereign Ward**

Change proposed for polling place in district SVC (move to Sovereign Harbour Yacht Club instead of Conqueror Hall, Harold Drive).

Comments: Supportive comments received from 13 Sovereign Harbour residents, Councillor Tarrant, the Sovereign Harbour Residents Association and the Eastbourne Labour Party.

## **Upperton Ward**

No changes are proposed.

## **5.0** Council consideration

5.1 Council is asked to consider the proposals and representations received and make a final decision. The Council is required to give reasons for its decisions in respect of the designation of both polling districts and polling places. Reasons have been given in appendix 1 with additional reasoning noted in paragraph 4.2 above.

# 6.0 <u>Implementation</u>

- 6.1 The new electoral register containing any revised polling districts will be published on 1 December 2010. The polling districts and polling places will become effective at all elections held after this date. It is important that the review is completed and that final decisions in relation to polling district boundaries are taken by the Council in advance of the publication of the new register. Failure to meet this deadline (and for this to be achieved a decision is required at this Council meeting) will mean that the register (or relevant parts thereof) has to be re-published at a later date with consequent cost implications.
- 6.2 In addition, the Council must publish:
  - All correspondence sent to the Returning Officer in connection with the review and all correspondence sent to any person who the Council thinks has particular expertise in relation to access to premises or facilities for persons who have different forms of disability.
  - All representations made by any person in connection with the review;
  - The minutes of any meetings held by the Council where details of the review have been considered.
  - Details of the actual designations of polling districts and polling places agreed as a result of the review.
  - Details of where the results of the review have been published.

# 7.0 Appeal to Electoral Commission

- 7.1 The grounds under which the review outcome can be challenged are that the Council has failed to:
  - meet the reasonable requirements of the electors in the constituency, or a body of them (i.e. the reasonable requirements of a particular area of the authority have not been satisfactorily met); or
  - take sufficient account of the accessibility to disabled persons of polling stations within a designated polling place.
- 7.2 The following may make representations to the Electoral Commission namely;

- not less than 30 registered electors in the constituency
- any person who made representations to the council when the review was being undertaken (except the Returning Officer)
- any person who is not an elector within the constituency who the Electoral Commission feel has sufficient interest in the accessibility of disabled persons;

Also the Returning Officer may make observations on any representations made to the Commission.

# 8.0 <u>Legal implications/risk assessment</u>

8.1 The Council is under a legal duty keep its polling place arrangements under review at not less than 4-yearly intervals and to follow prescribed procedures when carrying out such reviews.

# 9.0 **Policy and performance implications**

- 9.1 This review helps meet the Council's corporate plan objectives under the heading "thriving communities" for encouraging peoples' involvement in their neighbourhoods and the heading "sustainable performance" in ensuring a customer focus in the delivery of its services.
- 9.2 The Electoral Commission are empowered under section 9A of the Political Parties, Elections and Referendums Act 2000 to set out for local Returning Officers and Electoral Registration Officers the performance standards to be achieved in the conduct of their duties. This review and the associated documentation will help demonstrate that Eastbourne Borough Council is meeting the required standard.

### 10.0 Financial and resourcing implications

10.1 The impact of the review recommendations is essentially neutral, as once St Andrew's Church Hall is back in use the number of venues to be hired will be unchanged. The estimated cost of venue hire for the 2011 elections is c.£6,500. In addition there are the staffing costs of a presiding officer and poll clerks. Election costs are borne by the body holding the election. For parliamentary elections and referendums the Government pays and East Sussex County Council pays for county elections.

The following are the comments received regarding the proposals made.

# **Sovereign Ward**

The following comments were received in regards to the suggested proposal to change Sovereign Ward SVC polling place from Conqueror Hall to Sovereign Harbour Yacht Club:-

**Comment received from a resident of North Harbour:** 'I am writing as a North Harbour resident to say that I would be in favour of the Polling Station moving from Conqueror Hall to the Sovereign Harbour Yacht Club.

I have driven to Kingsmere once and found parking a major issue on Polling day, and I have walked a couple of times, and found getting to Conqueror Hall is a bit of a circuitous route from North Harbour.

I think the SHYC would offer a much better alternative.'

Comment received from residents of Vancouver Road Sovereign Harbour North: `As residents of Sovereign Harbour my wife and I write to support the change of polling station for the Sovereign Ward from Conqueror Hall in Harold Drive; to Sovereign Harbour Yacht Club (SHYC).

Conqueror Hall is inconvenient to drive to, the route being convoluted. Parking is always a problem. In contrast SHYC has adjacent unlimited free parking and is located much nearer to the centre of gravity of the electorate than Conqueror Hall. It is easily accessed from a roundabout. Finally it's use as a polling station would involve some recognition by our Council of the role SHYC plays on the harbour in the absence of any publicly funded community facilities. In much the same way as church halls and the like.'

**Comment received from Councillor Susan Tarrant:** 'I think on behalf of residents in the north harbour the new proposed site would be most welcoming. I did send through a couple of letters I received earlier this year of people not wanting to go to Kingsmere. I only hope that people from Kingsmere will make the journey into the harbour. The problem for either set of residents is the dual carriage way which is a problem for both groups.'

**Comment received from a resident of Hobart Quay:** 'I would support the move of the polling station from Conqueror Hall to SHYC.'

**Comment received from a resident of Midway Quay:** 'A polling station at the SHYC would be most welcome.'

**Comment received from a resident of The Piazza:** 'I think it would be a good idea to transfer the polling station to SHYC. Most people could walk saving Fuel.'

**Comment received from a resident of Tasmania Way:** 'please move polling station to SHYC.'

**Comment received from a resident of St Lawrence Way:** 'I fully support the move of polling place to Sovereign Harbour Yacht Club, much more convenient.'

Comment received from residents of St Lawrence Mews: 'As a resident of North Harbour we would welcome a change of Polling Station to SHYC because we could walk there easily. It would mean most other residents could do likewise and not have to use the car.'

**Comment received from a resident of Admiralty Crescent:** 'I would support a move of our polling station to Sovereign Harbour Yacht Club.'

**Comment received from a resident of Tasmania Way:** 'Both my wife and myself support the suggestion to move Sovereign Ward – SVC – polling place to the Harbour Yacht Club. So much more convenient.'

Comment received from resident of Harbour View, Sovereign Harbour: 'I have read the proposed list of Polling Station venues for the May 2011 elections and wish to wholeheartedly agree to the change for the Sovereign Ward to be moved to the Sovereign Harbour Yacht Club venue.

I believe with the vast expansion of Sovereign Harbour, particularly the North Harbour, would make this a sensible option bearing in mind the number of residents and taking into consideration the larger parking facilities in the new location.'

Comment received from a resident of Canary Quay: 'Although I live in Sovereign Harbour South and am therefore not affected, I wish to support the proposal to move the polling place for SVC to the Sovereign Harbour Yacht Club. This area is close to the central hub of the Sovereign Harbour development and the facilities for parking are excellent. People will have less excuse not to vote if the venue is close to hand. Voters will also have the opportunity to see a glorious view.'

Comment received from the Election Agent of the Eastbourne Labour Party: 'Thank you for sending me the consultation document re the above. I have no comments to make on behalf of Eastbourne Labour party other than to welcome the change in Sovereign Ward to the Yacht Club.'

**Comment received from a resident of St Lawrence Way:** 'I am writing to express my support for the proposed change of polling station venue in Sovereign Ward SVC from Kingsmere to the Sovereign Harbour Yacht Club. This will be much better for all the residents in Sovereign Harbour North who are the vast majority of voters in this polling district and who, for many, find difficulty travelling into Kingsmere.

The yacht club is a prominent, easily accessible venue with excellent road access and parking in the immediate vicinity.

Of course, if Sovereign Harbour ever gets the community centre that it deserves, the polling station should ideally be located there. Meanwhile, the yacht club is the next best thing.'

### Review of Polling Districts and Polling Places in the Borough of Eastbourne
