- **9. Motions.** The following motions have been submitted by members under council procedure rule 13:-
  - (a) Queen's Jubilee floral displays. Motion by Councillor Liddiard:-

In celebration and appreciation of Her Majesty Queen Elizabeth II's Diamond Jubilee in the calendar year 2012 and also the Olympic Games (London 2012), Eastbourne Borough Council commits to ensuring that all floral displays under the councils control and influence within the borough (including the Carpet Gardens, Parks, gardens and open spaces) have the floral displays colour co-ordinated in red, white and blue (and green to encourage the councils green ethos) in honour of these events showing the colours of our national standard..

- **(b) Honorary Aldermen.** Motion by Councillor Belsey:-
  - (1) That a special meeting of the Council be convened at which the Council consider motions to be put before them to exercise their powers under Section 249 of the Local Government Act, 1972 and confer the title of Honorary Alderman upon David Stevens, Mary Pooley, Graham Marsden, Olive Woodall, Ann Murray and Barbara Goodall in recognition of the eminent service they have given as past members of Eastbourne Borough Council.

(2) That the Head of Strategy and Democracy be authorised to make all necessary arrangements in liaison with Group Leaders.

Note as to past service:

David Stevens: 24 years service. First elected on 5 May 1983 for the Meads Ward and continued to serve for that ward until his retirement on 7 May 2007. He also served as Mayor in 2001/02.

Mary Pooley: 21 years service. First elected on 7 May 1990 for Hampden Park ward and continued to serve for that ward until her retirement on 9 May 2011. She also served as Mayor in 2007/08.

Graham Marsden: 20 years service. First elected on 6 May 1991 for Upperton ward and continued to serve for that ward until his retirement on 9 May 2011. He also served as Mayor in 2005/06 and as Leader of the Council for 2000/02 and again in 2004/05.

Olive Woodall: 20 years service. First elected on 6 May 1991 for Hampden Park ward and continued to serve for that ward until her retirement on 9 May 2011. She served as Mayor in 2002/03 and 2003/04. She also served as a county councillor for the Park/Hampden Park division from 1997 until her retirement in 2009.

Ann Murray: 19 years service. First elected on 9 May 1988 for Upperton ward and continued to serve for that ward until 7 May 2007.

Barbara Goodall: 16½ years service. First elected on 6 May 1991 for Ratton ward and served until 4 May 1995. Elected again for Ratton on 3 September 1998 and continued to serve until her retirement on 9 May 2011. She also served as Mayor in 2004/05.

(c) Five Acre Field. Motion by Councillor Jenkins:-

Following the recent unlawful incursion of Five Acre Field by a group of travellers, we call on this Council, as a matter of urgency:

- to come forward with proposals to ensure the security and protection of this important council owned local recreation space,
- to come forward with an agreed protocol between the Police and the Council for removal of unlawful occupants, and
- to press the Government to come forward with proposals that will ensure that local authorities and the Police have the power to act without delay in such instances..
- (d) Emergency road repair programme. Motion by Councillor Shuttleworth:-

Eastbourne Borough Council calls upon East Sussex County Council to review its procedures and works programme to address the poor state of many roads within Eastbourne. Whilst recognising the severity of last winter this Council finds it unacceptable that there are so many potholes remaining across the roads in Eastbourne. Further, the Borough Council is pressing for an emergency road repair programme using funds obtained from Eastbourne residents and visitors through the County Council's pay to park programme.
