### **IMPORTANT: Tariff Chart Consultation**

On the 20<sup>th</sup> August 2008, the Full Licensing Committee decided that the "extras" system currently in place will be dispensed with, and will be removed from the Hackney Carriage table of fares.

The Full Licensing Committee also decided that a simplified tariff will be put in place to make it easier for the travelling public to understand. This will take into account the removal of the "extras" system and moves towards a simplified rate structure.

All hackney carriage proprietors are encouraged to participate in the enclosed hackney carriage fare tariff chart consultation process. It should be noted that the Full Licensing Committee has already agreed the form of the future fare tariff card and your views are being sought as the levels at which any tariff should be set.

An example of the agreed taxi tariff chart is attached with blank spaces for completion by you to indicate what you feel the appropriate value for the flag fall and subsequent charges per mile at the stipulated times and rates should be.

There is also space to make further suggestions that you feel Committee should be aware of when formulating the final version of the new tariff chart.

The Licensing team would also appreciate it if you liaise with any journeymen, who utilise your taxi, to obtain their views prior to completing and returning the enclosed consultation form.

I urge you to take part in this consultation process, and to provide constructive feedback to ensure that the levels suggested adequately cover the cost of providing the service, whilst also ensuring that it remains accessible to the travelling public. The consultation is scheduled to take place between 8<sup>th</sup> September 2008 - 12 noon on 31<sup>st</sup> October 2008.

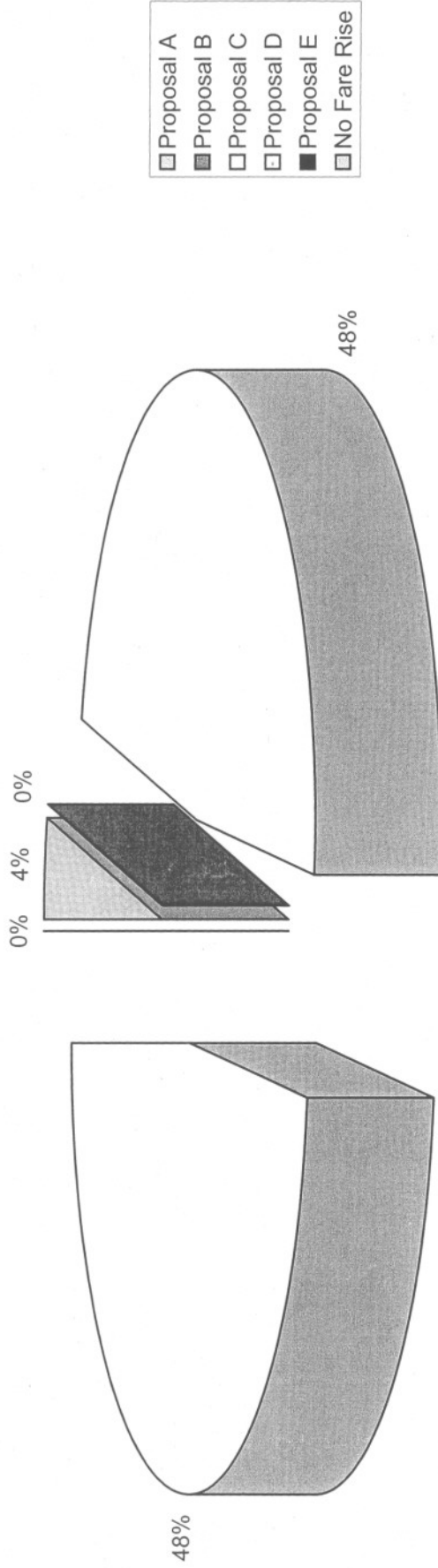

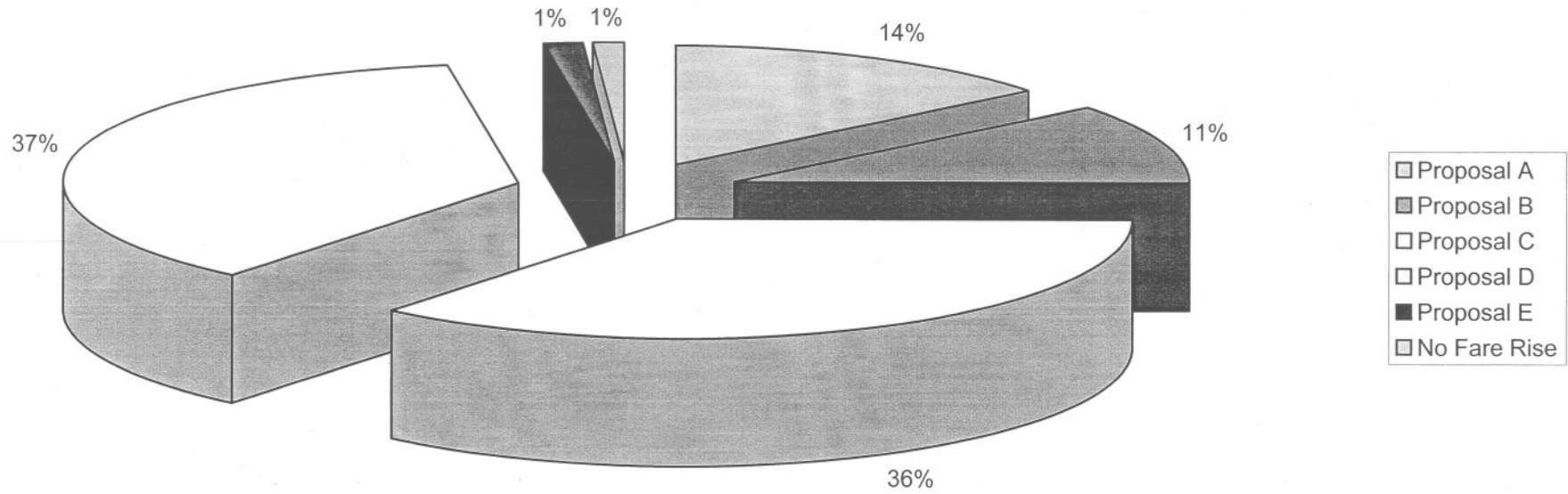
