2.	Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 – Conditions consistent with the Operating Schedule

All Licensing Objectives

1. An open, modern self-service grocery store - well illuminated.
2. Staffed and managed by experienced personnel.
3. CCTV monitoring.
4. Closing shutters at front.

Prevention of Crime and Disorder

5. CCTV recording equipment/cameras installed, operated and maintained to Sussex Police specification - 28 days hold and retrieval.
6. Incident/refusal register maintained and available for inspection.
7. For a period of six months all alcohol containers to be marked and identified from point of supply in liaison with Sussex Police.

Public Safety

8. First Aid Station on site for staff and customers.
9. Fire assessment and precautions to current standards.

Prevention of Public Nuisance

10. Constant surveillance within store and appropriate level within immediate vicinity outside the shop.
11. Be an active participant in local Shop Watch Scheme.
12. For a period of six months all alcohol containers to be marked and identified from point of supply in liaison with Sussex Police

Protection of Children from Harm

13. 'Proof of Age' signs prominently displayed Challenge 25 adopted.
14. 'Under Age' restriction signs displayed.
15. Identity/age documents to be shown as required.

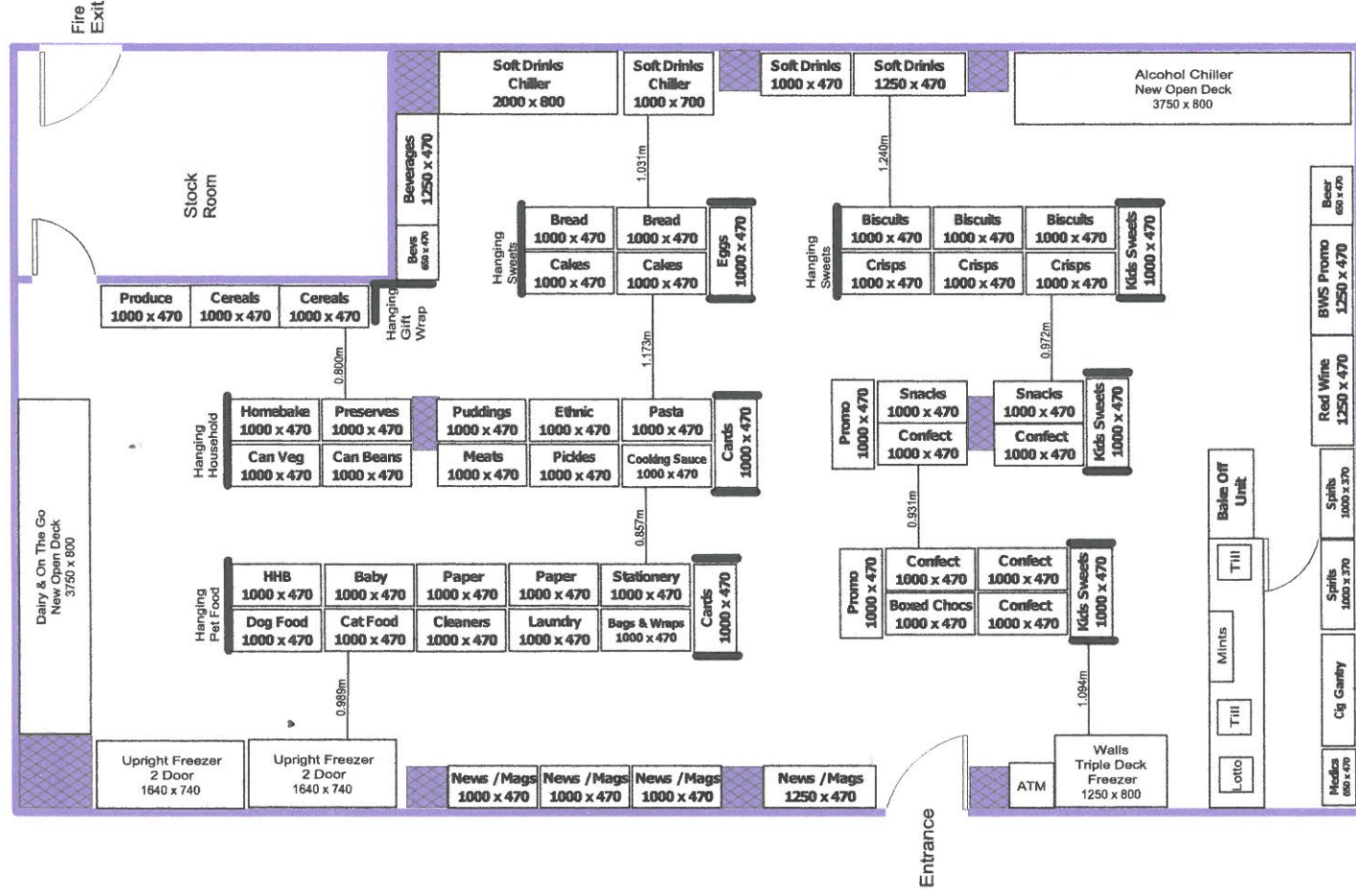
