### **Overarching commentary : Prosperous Economy**



#### Latest Note

Significant progress has been made on two of the economic development key projects under the Prosperous Economy Theme. Firstly the planning application for the £70million Arndale extension is being processed and is now programmed to be debated at a special planning committee meeting on 23 August. The progress bar is showing no progress because there are no key milestones in the first quarter but clearly the project is moving forward and progress will be recorded in the second quarter as programmed. The complimentary project of improving the public realm of Terminus Road has seen ESCC make a significant contribution of £2.5 million towards the cost, primarily from the parking funds they have received from the town. Both projects are therefore on track for completion during 2016. The Sovereign Harbour Supplementary Planning Document completed its public consultation phase and the representations are currently being analysed. The responses will be debated at a future Cabinet. This is an important step in creating the planning policy position for the submission of a planning application by the land owners. This will start the process of securing consent for the business land.

The loyalty card scheme is showing no progress on the progress bar because there are no key milestones in the first quarter.

Quarter One saw a great start to the 2012 summer season with the reopening of Treasure Island, as a family friendly leisure attraction and a number of high profile events attracting a range of interest groups and ages to the resort. Starting with the launch of the Eastbourne Festival, in the town centre, in April, we saw the return of the Lambretta Club of GB; Magnificent Motors consolidated its successful relocation to Princes Park for the second year, in May, with record vehicle entries and we also supported the second cycling festival and introduction of a 5km run and duathlon. June saw the new Sunshine Carnival and the second Fiesta event which, combined with the Diamond Jubilee weekend, resulted in a bumper weekend of events and activities including live bands, fireworks and a screening of the concert from Buckingham Palace enjoyed by thousands.

The month was particularly successful for the Aegon International Tennis with record figures of 38,000 and Tamira Paszek and Andy Roddick taking the titles, screened in over 50 countries via Eurosport. We responded to a number of needs of visitors and attractions with the successful installation of new seafront signage and milestone markers and problems with the structure of the Bandstand were overcome as we located the Titanic Concert at the Congress Theatre and launched Bandstand on the Beach whilst it was closed for essential works. A number of campaigns to market and promote the resort in the lead up to the Olympics secured us the Swedish Team who used the Devonshire Park Centre as a pre-training camp and a booking of the Boat Project by Lone Twin. We also launched a new online and London based marketing campaign in advance of the Olympics; Love Sussex and we were awarded third place for the best tourist website for Visiteastbourne by the British Resort and Destination Association.

The weather continued to present challenges as we saw the worst May and June on record, which has affected use of the seafront and deckchair and ticket sales, but it didn't prevent us from bringing 2,000 delegates from around the world to Eastbourne for the International Dance Competition at Devonshire Park. The appointment of TNS – a well known visitor research consultancy – kick started the Visitor Economy Study, with the aim to consolidate our market intelligence and data into a comprehensive action plan for tourism marketing and investment.

#### Latest Note

A number of the projects have progressed during the last quarter. In particular the Joint Waste Procurement has reached its final stage with final prices recently submitted. These are being analysed and the preferred bidder will be approved at a Special Cabinet on 5 October. During the last quarter the annual Grot Spot campaign was started with all neighbourhood panels and Councillors asked to name a grot spot they would like to seek tackled. The next stage will be to compile a list of projects to be carried out during September and October. Last year 30 grot spots were improved. Under the transport theme, the borough wide Parking Strategy has been adopted. This will a co-ordinated approach to parking created by future developments in particular the identified sites in the draft Town Centre Area Action Plan. The Pride in our Parks theme saw the completion of the Manor Gardens Skate Park. Much attention has been focussed on Princes Park which saw the confirmation that it has retained its Green Flag award for 2012; it is the first green space to receive its Queen Elisabeth Fields in Trust status protecting the space in perpetuity; and a new children's attraction was completed in the form of the splash pad, just in time for the drought order to be lifted. All targets have been met this quarter with the exception of the identifying the funding for some of the projects are supported in Eastbourne.

For information the progress bar on allotments, Eastbourne Park and managing waste responsibly are currently showing as 0% completed because there are no key milestones in the first quarter. However Members will know that significant work is progressing in these areas, particularly the new waste collection contract which is progressing according to timetable.

### **Overarching commentary : Thriving Communities**



#### Latest Note

Changes to the social security and welfare systems, being introduced by the government as part of the Welfare Reform Act, are expected to have a significant impact on residents in Eastbourne. The Council's Housing Services team are working with Eastbourne Homes and other partners to develop ways to help the resident to manage the changes. An Action Plan will be ready by the beginning of September. At a County level Eastbourne has taken the lead in pulling together an East Sussex Welfare Reform Action Plan to agree how collectively we can bring together all our resources to most effectively and efficiently help residents adjust to the changes. Further work will be completed over the coming months to make sure residents are aware of the changes and can get informed and coherent advice on how to manage potentially reduced incomes, both now and in the future. From April 2013, the Council will implement a new Council Tax Support scheme following a 10% reduction in funding from central government. All homes in England are subject Council Tax. However, in some situations, residents may be entitled to a discount, or even be exempt from paying the bill at all. Council Tax Benefit is currently the national system for helping low income households to pay their Council Tax Benefit is own scheme to help people pay their Council Tax bills. Currently, all Council Tax Benefit payments made by the Council are paid for by the Government. From April 2013 this support is to be reduced by 10% - an annual financial loss for Eastbourne of just under £1m. The Council has been actively working with other East Sussex council to draft a a local Council Tax Support Scheme. Public consultation on the proposed scheme will go live early August.

The YMCA has established a number of new groups including a Young Women's Group in Old Town, youth sessions in Langney, Music Group in Devonshire and healthy eating and football in Willingdon Trees. Work to complete the Hamden Park Internet Hub has progressed well and is due to be finished in July. The new Shinewater/North Langney Neighbourhood Management Group has agreed its area Action Plan and is starting to do the work needed to deliver the outcomes agreed in the Plan. Crime figures continue to remain low. However, shoplifting remains a concern and the police and partners are actively developing actions to tackle this priority area.

The new 62 bedroom Extra Care scheme at Cranbook has now been formally opened and work continues to progress proposals to develop of new homes on former sheltered schemes. Opportunities for Eastbourne to benefit from the government's Green Deal programme (designed to help people fund and install energy efficiency measures) are now being explored following the publication of further details about the scheme. Extensive housing market research has been underway to inform both the forthcoming housing strategy 'At Home in Eastbourne' and the Strategic Housing Market Assessment for the Core Strategy. This has included liaison with estate agents and landlords. Community and resident consultation is now underway, with a strong and vibrant response already being recorded by the Housing Services team.

The last quarter has seen work to develop a business plan and designs for the front of The Congress continue, supporting the overall business strategies and opportunities for the Theatres. Notable successes for the programmes included All the Fun of the Fair generating a profit of £30,558; Chicago grossing £125,000 and Michael McIntyre's pre Arena warm up gig which netted us £10,000 surplus. We continued to develop the creative programme with productions such as DNA and Diary of Anne Frank, although these are more challenging in attracting audiences, it is building solid relationships with bodies such as the Arts Council and touring producers. One of the most significant results of the quarter, for all the venues, was the creation of the in house catering offer through the successful termination of the previous contract and work is underway to build and develop this service.

The Sports and Leisure service has reported a successful period with figures indicating an 11% rise on adult visits compared to last year and 3.5% on juniors. This was supported by a successful programme of school holiday activities over Easter and half term and we delivered the first annual Sports Festival which saw over 1,200 people participate in the sports offer and the opening of the new skate park at Manor Gardens has proven a success with young people and park visitors, with many positive comments received about the facility. Our relationship with the LTA and Tennis Foundation continues to grow and we achieved Beacon Status for the Courts at Fisherman's Green, with a funded tennis coaching programme to mark the occasion. Towner Gallery was successful in winning a nation-wide competition for 'Museums at Night' in May, which it celebrated alongside the annual schools exhibition of work by 1,000 local children and Silent Voices – a collaboration with YMCA for young people. Toward the end of the quarter, the culmination of a partnership with BBC South East resulted in The People's Monarch installation, which attracted 16,000 visitors from far and wide in just two weeks.

The Museums Service set in train a new project that brings the many artefacts and skeleton pieces within the Local History Collection, to life - with a new Eastbourne Ancestors project that

received £72,000 in Lottery funding. The funding established a forensic 'lab' and incident room, where staff and volunteers work with schools and students to reconstruct the physical attributes and genealogy of the town's ancestry. Lower visitor numbers at The Redoubt, following its winter closure were boosted with a number of large events and the creation of an education space.

### **Overarching commentary : Sustainable Performance**



Latest Note

Q1 has seen pleasing progress against all the key projects within the Sustainable Performance theme. The second phase of the Agile Working Programme has been progressing very well with more relocations of staff into 1 Grove Road as well as the development of our IT and telephony networks across our other key buildings.

In the Asset Management project, we have completed the first phase of condition surveys and lease events and are now moving on into the second tranche of properties. The relationship with ESCC is working effectively and while there is still a great deal of work to be done, we are making progress towards the implementation of the CIPFA recommendations for a sustainable asset portfolio.

Perhaps the most significant development in this quarter was the adoption of the Future Model for the Council by Cabinet and the approval for the delivery of Phase 1 of the programme. The Future Model will see the most significant change to the way in which the organisation is structured in recent years and is designed to improve our ability to deliver our services to residents and visitors as well as make a real contribution to the economic sustainability of the Council in the next 3-5 years.

Over the last 3 months the programme has moved from approval through its "Mobilisation" phase and is now developing the both the "Blueprinting" of future processes as well as the "Target Operating Model" for the teams involved in this phase of delivery.
