- 5 The Committee considered crime and disorder matters under the new powers and extended remit of the Scrutiny Committee as set out under the Police and Justice Act 2006 and made recommendations for reviews for 2011/12.
- 6 The Committee also considered in the past year:

 - Value for Money Studies and Benchmarking Reviews
 - Scheme of Delegation to Officers
 - The Duty to Respond to Petitions
 - Moving Scrutiny Forward at Lewes District Council

 - Chair of Council's Business Report.
