The Chair of the Council drew Councillors attention to the petition which had been submitted to the Council earlier in the meeting by Samira Harris. The petition contained in excess of 2200 signatures and related to the proposal, in the Lewes District Local Plan – Core Strategy Proposed Submission Document, which might result in the demolition of the Phoenix site, Lewes, Page 8 of 13 and, consequently, the loss of employment, the creative community which worked at that site and a community infrastructure which supported education and entertainment facilities. The petition asked that the government support such important elements of the community.

The Director of Planning and Environmental Services circulated a document entitled "Lewes District Council – Full Council meeting, 5 December 2012 -Report No. 184/12 - Lewes District Local Plan – Core Strategy Proposed Submission Document" (a copy of which is contained in the Minute Book), which set out details of responses to several issues that had been raised by Cabinet at its meeting held on 20 November 2012. A copy of that document was also made available to all those attending the meeting.

The Director of Planning and Environmental Services and the Planning Policy Manager then gave Council a presentation and answered Councillors questions on matters relating to the Core Strategy Proposed Submission Document, as referred to in Report No 184/12 and in the recommendations contained in Minute 89 of Cabinet at its meeting held on 20 November 2012. The presentation also related to the document which had been circulated at the Council meeting.

The Director of Planning and Environmental Services introduced to the meeting Lara Southam, Planning Policy Officer, South Downs National Park Authority (SDNPA), who also answered some of the Councillors questions on matters relating to the Core Strategy Document and, in particular, to the views of the SDNPA in respect of proposed changes which the Council might wish to make to that Document.

Council considered Report No 184/12, the Cabinet recommendations in respect thereof and the document which had been circulated at the Council meeting.

The Cabinet Member for Planning, Councillor Jones, thanked the Council's Officers and those of the SDNPA for the work that they had undertaken during the production of the Core Strategy Document.

Council came out of committee following which the Leader of the Council, Councillor Page, moved, and Councillor Robertson seconded, the motion that:

- The recommendations of Cabinet held on 20 November 2012 contained in Minute 89 relating to the Lewes District Local Plan – Core Strategy Proposed Submission Document; and
- (ii) The issues set out in the document which had been circulated at the Council meeting entitled "Lewes District Council – Full Council meeting, 5 December 2012 - Report No. 184/12 - Lewes District Local Plan – Core Strategy Proposed Submission Document",

be received and adopted subject to the following amendments (NB All page numbers referred to below relate to the Core Strategy Proposed Page 9 of 13 Submission Document itself that was circulated with the Agenda for the Cabinet meeting held on 20 November 2012, not to the page numbering of the Cabinet Agenda papers):

- Revise the paragraph relating to Peacehaven & Telscombe on page 19 ("Section 2 – A portrait of Lewes District") to include details in respect of East Saltdean;
- (b) ".....hubs, such as the railway station. The retail provision on offer in the town will have been improved, by developments that encourage a rich and diverse mix of shops and other town centre uses, and advantage will have been......" (page 27 – part paragraph at top of page refers). Similar text to be included in the paragraph relating to Lewes town (page 27 refers) and in paragraphs relating to all other areas where possible (NB Such amendments to be on the basis that they can be approved by the Director of Planning at the South Downs National Park Authority without delaying progress of the Core Strategy Document);
- (c) ".....ageing population. A key element of this objective will be ensuring that a suitable mix of housing size, type, tenure and affordability is achieved including consideration being given to the needs of individual settlements in such respect." (page 29 – text in standard type in paragraph 3 refers);
- (d) "To ensure that the district reduces causes of climate change, including through the implementation of the highest feasible standards of sustainable construction techniques in new developments and be proactive regarding climate change initiatives." (page 31 text in bold type at start of paragraph 10 refers);
- (e) Insert a glossary in the Document in which a definition of the word "sustainable" is provided particularly with regard to its mention on page 32;
- (f) ".....(this could include A2 Financial and Professional Services, A3 Restaurants and Cafes, A4 Drinking Establishments and A5 Hot Food Takeaways and community space)." (page 47 – 6th bullet point refers);
- (g) ".....will be further expanded upon in the masterplan, which will be subject to approval from both the National Park Authority and District Council in consultation with residents, businesses and community groups on site and in the local area." (page 48 top paragraph refers);
- (h) "outdoor sports facilities (with natural or artificial surfaces, either publicly or privately owned) and cycleways" (page 91 – Page 10 of 13

paragraph 7.77 – 4th bullet point refers);

- (i) ".....reduce traffic levels in areas of reduced air quality, particularly in town centre locations, and promote the opportunity for cycling through the provision of cycleways."
 (page 94 Core Policy 9 (Air Quality) paragraph 5 refers);
- (j) "Core Policy 12 Flood Risk, Coastal Erosion, Sustainable Drainage and Slope Stability" (page 104 – the heading of Core Policy 12 refers);
- (k) The Director of Planning and Environmental Services reviewing the text set out in the boxes which define the Core Policies with the aim of making such text easier to understand; and
- (I) The Director of Planning and Environmental Services reviewing the text set out in Spatial Policy 5 – Land north of Bishops Lane, Ringmer (page 56 refers) in light of the text set out in the document which was circulated at the Council meeting, so as to ensure consistency between them.

113 Notices of Motion

The Chair of the Council reported that a Notice of Motion had been submitted under Council Procedure Rule 13 by Councillor Gardiner relating to planning and housing matters.

In accordance with Council Procedure Rule 13, Councillor Gardiner moved, and Councillor Jones seconded, the Notice of Motion as follows:

Planning and housing

"This Council wishes the Secretary of State for Communities and Local Government to note the following:

Lewes District Council believes that local people, through their democratically elected local authorities, are the most suitable judges of

what development is acceptable in an area and the suitable level of contributions that developers need to make;

Lewes District Council opposes:

The Secretary of State's proposals for the Planning Inspectorate to have powers to override agreements between Councils and developers over the number of affordable housing units allocated to planning applications.

The Secretary of State's proposals for planning permission to only be needed for extensions from the rear wall of any home reaching beyond 8m for detached homes and 6m for others (currently planning permission is required for extensions of more than 3 metres for attached houses and or 4 metres for detached houses

The Secretary of State's intention to override Section 106 of the Town and Country Planning Act of 1990 which will allow developers to immediately appeal to the Planning Inspectorate over the allocation of affordable housing units in any scheme with which they may be concerned.

The Secretary of State's proposals for the Planning Inspectorate to take planning powers away from local authorities which he deems to be slow or of making poor quality planning decisions in determining applications.

This Council notes that the current Coalition government did listen earlier in the year over concerns regarding the National Planning Policy Framework and revised its plans accordingly, and so urges the Government to listen to the concerns being expressed by the cross-party LGA;

This council however welcomes other parts of the stimulus package including:

£300 million to provide 15,000 affordable homes across the country

An extension of the refurbishment programme to bring an extra 5,000 empty homes back into use

£280m for FirstBuy, the shared equity scheme to give a futher 16,500 first time buyers the chance to own their own homes

Up to £10bn of guarantees to housing associations, property management companies and developers which will be able to use the guarantees to secure lower borrowing costs. This will lead to hundreds of thousands of extra rental homes being built.

This council also notes the following facts:

the record of Government from 1979 to 1997 during which 1.1 million social

homes were lost, through a failure to invest in replacements of right-to-buy sales. In 1997 one million families were on social housing waiting lists.

the record of the previous Labour government on providing affordable social housing – and that during their 13 years in power, the social housing stock fell by another 420,000 houses, as Labour continually failed to build more homes than they were selling off. In the meantime, social housing waiting list soared to almost 1.8million, a rise of 741,000 families.

This council resolves to formally write to the Secretary of State for Communities and Local Government, outlining this council's opposition to the plans."
