

Have your say on our Council Tax Support Scheme

Council Tax Benefit (CTB) is a national scheme that helps those people with low incomes to pay their Council Tax. The Government sets the rules regarding who can claim and how much benefit they would receive. In April 2013, the national scheme will be abolished and in its place, local authorities have been asked to bring in their own Council Tax Support Schemes.

At present all of the money we give in CTB is funded by the Government, but from April 2013 this will be reduced by 10% which means we will have around £1 million less to help low income households in Lewes district.

As a result of this we will need to make some difficult decisions about who will get financial support to pay their Council Tax, and how much they will receive. The Government has told us we must protect pensioners but this means the majority of working age people who need help will have to pay more towards their Council Tax.

We have to publish and consult people on a 'draft scheme'. What we'd like to find out through this questionnaire is whether you think we should use our 'draft scheme' or another scheme. The other possible schemes are described in question 9.

We have worked with the other councils in East Sussex to look at different options and how these might affect local people. Currently, one in five (8,122) households in Lewes district receives CTB and of these, 3,957 will be directly affected by any changes we make to the level of support we can provide.

Please fill in the following questions. It is important that we hear from you, whether you receive CTB or not, as the changes could affect all taxpayers in Lewes district. The whole survey should take 10 minutes to complete, but if you run out of time, you can skip through by pressing the 'next' button. 3.a Key Principles

Lewes District Council has proposed a 'draft scheme' for our Council Tax Support Scheme. This is based on three key principles.

We have taken the key principles from the last question and have used these to design the draft scheme (Scheme 1) for working age claimants (described in detail in the easy read guide). Alternatively, we could introduce scheme 2 or 3 below.

The questions on the next five pages will explain more about the draft scheme, and then at Question 9 we will ask you which of the following three schemes you think would be best.

Scheme 1 (draft scheme): to meet the majority of the 10% shortfall by using flexibilities on Council Tax discounts and exemptions. To reduce the amount of support received in order to finance the remainder of the 10% shortfall by implementing our draft Council Tax Support Scheme.

Scheme 2: to introduce a scheme which proposes no changes to the current levels of Council Tax support. This would make use of the flexibilities on Council Tax discounts and exemptions, but would mean potential cuts to services and / or an increase in Council Tax for all residents of Lewes district.

Scheme 3: we may consider a further scheme based on your feedback and ideas you may have. This may include parts of the alternatives above.

Your views on our Draft Scheme

The next five questions are about our draft scheme. These are the ways in which we could make up the shortfall in our funding. These will affect the amount of Council Tax that claimants in different personal circumstances have to pay in future.

The Council would like to know whether any of the following are strongly supported or particularly unpopular.

Savings and investments (capital limit)

Currently, people who have up to £16,000 in savings might be able to get help with paying their Council Tax. We propose to lower this limit and the draft scheme suggests reducing it to £6,000.

Second adult rebate

A small number of people (currently 46) whose income is too high for them to qualify for Council Tax Benefit, can currently get up to 25% discount off their bill if they have a second adult living with them (not their spouse/partner) and that person has a low income. We propose to remove this rebate.

Non-dependant adult contributions

Some people who receive Council Tax Benefit have other 'non-dependant' adults living with them (not including their spouse/partner, but often another family member aged 18 or over such as a grown up son or daughter). The amount of benefit claimed partly reflects the circumstances of those adults, e.g. their income.

Please refer to the Table of Non-dependant Deductions for some examples.

At the moment, if the adult gets Income Support, Jobseekers Allowance or Employment Support Allowance (both income-based) this does not affect Council Tax Benefit. The draft scheme proposes this should be changed so that claimants would have to pay £5 per week more towards their Council Tax.

Our draft scheme <u>also</u> proposes that **all** current non-dependant adult deductions are doubled. This means that claimants living with other non-dependant adults would have to pay more towards their Council Tax.

Maximum support

There is currently no maximum amount of support a working age person can get to help them pay their Council Tax. Our draft scheme proposes a maximum level of support of £20.00 per week to help pay Council Tax or a similar way of limiting the amount we can award to any one claimant.

This approach would affect people living in higher banded houses more because their Council Tax is significantly higher than the proposed maximum amount. Householders in smaller homes in Council Tax bands A or B would be less affected. The weekly Council Tax payable for each Council Tax property band are as follows:

 Band A . . . £20.09 - £21.61
 Band E . . . £36.83 - £39.63

 Band B . . . £23.43 - £25.22
 Band F . . . £43.52 - £46.83

 Band C . . . £26.78 - £28.82
 Band G . . . £50.22 - £54.04

 Band D . . . £30.13 - £32.42
 Band H . . . £60.26 - £64.84

For example, if a household's Council Tax was £25.22 per week, and they were entitled to maximum Council Tax support, we would pay £20 per week towards their bill and they would pay £5.22.

Minimum support

There is currently no minimum amount of financial support that someone can get to help them pay their Council Tax.

Our draft scheme proposes to introduce a minimum amount of support of £5 per week. This means that unless someone is entitled to at least £5 per week, they will not get any help at all to pay their Council Tax.
