Purpose of Report:

To confirm the changes and appointments to Committee memberships.

To note the changes and appointments to Outside and Joint Body representatives.

Officers Recommendation(s):

Reasons for Recommendations

1 To comply with the Council's legal duties and to implement changes in accordance with the Constitution.

Information

- The Appointments 2014/15 report that was agreed at the Annual Council meeting on 7 May 2014 showed some vacant seats on Committees that remained to be filled by the relevant Political Groups.
- Following the recent changes to the membership of Cabinet and Councillor Tony Nicholson becoming Chair of the Council, some changes are required to the appointments on particular Committees, Outside and Joint Bodies which require the representatives to be Cabinet Members, or where the representatives cannot be Cabinet Members.

Committee memberships

- **4** The Leaders of the Political Groups informed me of the appointments that their Groups wished to make to those Committee memberships as follows:
 - **4.1** Audit and Standards Committee Councillor I A Nicholson replaces Councillor E C Merry.
 - **4.2 Devolution Committee** Councillor A Dean fills the vacant Liberal Democrat Group seat.
 - **4.3 Employment Committee** Councillor E C Merry (Chair) fills the vacant Conservative Group seat. Councillor M P Chartier fills the vacant Liberal Democrat Group seat.
 - **4.4 Licensing Committee** Councillor S Adeniji fills the vacant Independent Group seat.
 - **4.5** Planning Applications Committee Councillor E E J Russell fills the vacant Conservative Group seat. Councillor S Adeniji fills the vacant Independent Group seat.
 - **4.6 Scrutiny Committee** Conservative Group seat currently vacant (to replace Councillor E C Merry).
 - **4.7 Housing Working Party** Councillor P A Howson (Chair) to replace Councillor I A Nicholson.
- In accordance with Council Procedure Rules (Procedures for Appointments, page D23, paragraph 3.4), the Assistant Director of Corporate Services has made these appointments which now need to be confirmed formally by Council.

Outside and Joint Body representatives

- The Leader of the Council, following consultation with the Leaders of the Minority Groups, informed me of the changes to representatives on the affected Outside and Joint Bodies as follows:

 - **6.4 Housing Consultative Panel** Councillor P A Howson replaced Councillor I A Nicholson.

made these appointments which were confirmed by Cabinet at its meeting on 7 July 2014.
