12 Planning Applications

The committee considered Report No. 128/07 on planning applications recommended for determination.

A supplementary report was circulated at the meeting summarising correspondence received since the preparation of the main report.

1) That the following applications be approved subject to the conditions set out in Report No. 128/07, or as shown below:-

LW/07/0077	Planning Application for An 850kw wind turbine comprising a tubular tower 44m high, a three bladed rotor with a diameter of 52m, overall height 70m, an underground cable to Glyndebourne and crane hardstanding area on Land at Mill Plain, New Road

Subject to (i) Completion of the Article 14 Direction procedure referring the application to The Government Office for the South East and the Secretary of State's formal decision as to whether to "call in" the application for her determination and (ii) the imposition of planning conditions to cover the following aspects:- (The detailed wording of the conditions is to be agreed with the Chairman, Lead Member and Councillor Eiloart and will be subsequently minuted).

- The requirement for wind speed and direction data to be accurately assessed over the course of 12 months by way of a temporary mast, details of which are to be submitted for prior approval of the Local Planning Authority.
- Renewal of the wind turbine and all associated equipment before expiration of 25 years from date of commissioning.
- Renewal of wind turbine and all associated equipment if it fails to supply electricity for a continuous period of 12 months.
- Prior approval of construction compound, parking, site turning and access widening works.
- Wheelwashing facilities for construction vehicles.
- Prior approval of construction programme.
- Programme of archaeological works.
- Noise controls (in liaison with Environmental Health Officer).
- Prior approval of details of coloured finish for all turbine components.
- Prohibiting of advertising on any part of turbine.
- Requirement for prior written communication of start date to Ringmer Gliding Club.
- Limitation of permission to submitted turbine details.
- Protocol for handling any noise complaints.
- Logging for windspeed and direction data.
- Monitoring of potential 'shadow flicker' effects.
- Submission of tv reception study.
- Restriction for hours of construction.
