### 153 LW/17/0955 - 11 Badgers Field, Peacehaven, East Sussex, BN10 8LQ

Heather Booth, Jack Dunkerton and Keith Nie spoke against the proposal.

#### Resolved:

1. That planning application LW/17/0955 for demolition of existing garage and construction of an attached annexe be refused.

### Reasons for refusal:

- 1. Access to the proposed self-contained annex would be unacceptable by reason of restricted width alongside the main dwelling side and rear elevations, to the detriment of occupies of both the annex and main dwelling being contrary to the provisions of Policy ST3 of the Lewes District Local Plan.
- 2. The proposal would constitute unacceptable intensification of use of the plot by reasons of activity associated with a self-contained annex property. The proposal is therefore considered to be contrary to the provisions of Policies ST3 and RES13 of the Lewes District Local Plan.

# 154 LW/16/0037 - Land On The South Side Of Sutton Drove, Seaford, East Sussex
