# What is Scrutiny?

Scrutiny is a key part of any local authority and Scrutiny Committees are in place to ensure that the Council's policies, plans, decisions and actions are being made in the community's best interest. Scrutiny functions were created as a result of the Local Government Act 2000.

Lewes District Council has one Scrutiny Committee which consists of eleven Councillors who are not on Cabinet to influence decisions and ensure the views and needs of local people are taken into account. This enables nonexecutive members to influence decisions and ensure the views and needs of local people are taken into account. It's about being a 'critical friend'.

# Data

The main Scrutiny Committee met five times in 2012/2013. Separate Panels to undertake Reviews met a further nine times and there was one call-in. This is an increase in meetings of 50% from 2011/12.

# What has been scrutinised?

# Provision of Affordable Housing in Urban Areas

A major review was undertaken by a Panel of seven Councillors to examine the provision of affordable housing in urban areas. This followed on from the recent review into the rural areas of the District. Councillors consulted with a wide range of stakeholders and residents in order to examine this issue in more detail.

The Panel made a series of recommendations that were taken and accepted by Cabinet in July 2013. These recommendations are being developed into a more detailed work programme by members of Cabinet and the Chair of the Panel. An update will be brought to a future meeting of the Committee. This review was entered into the Centre for Public Scrutiny's awards scheme.

#### Benchmarking across the Council

The Committee completed its three year programme of looking at benchmarking across the Council. It considered benchmarking from environmental health, housing, waste and recycling and human resources. Consideration of the services led to a series of recommendations being taken to Cabinet.

#### Complaints

The Committee examined data regarding complaints across the Council and made recommendations to improve the process for residents.

#### Localised Council Tax Support Scheme

The Committee set up a separate Panel which met three times to examine the new localised council tax support scheme that the Council had to implement. The Panel worked closely with members of the Cabinet and officers and was a key consultee for the Leader in establishing the new scheme. This Panel will continue into 2012/13 to help prepare the following year's scheme.

#### **Annual Budget**

This is considered every January in order to feed into the budget consideration for the Council. This led to some recommendations for the Committee to examine some areas in further details.

#### **Skate Park Petition**

As per the Council's petition's scheme which states that petitions that receive 750 signatures are taken to a Scrutiny Committee, Councillors considered a petition for a skate park in Seaford and made a series of recommendations for the Cabinet to consider.

# How have we engaged the local community?

A number of measures were put in place in the last year to increase the level of community engagement in Scrutiny at the Council. These included:

- Publicity material in District News and LDC News
- Meetings taking place outside of Lewes town
- Increased use of social media
- Consultation with Town and Parish Councils

- Engagement with local networks
- Direct invitations to groups and members of the community to engage with reviews

The performance measures above demonstrate the success of some of the community engagement activities. Future plans include the increased use of social media, and the holding of further meetings outside Lewes town and at different times of the day. The area which needs growth is attendance by members of the public at the main Scrutiny Committee.

# Looking Forward to 2013/2014

The main focus of 2013/14 will be the completion of work with voluntary and community organisations, as well as starting new reviews. Other suggestions for work, as well as ongoing projects have been approved, see Appendix A for the Committee's current Work Programme.

The Committee will also focus on the second year of the localised council tax support scheme.
