**Purpose of Report:**

1. For the Scrutiny Committee to receive a presentation concerning the reinstatement of the Lewes to Uckfield railway line, pursuant to the Scrutiny Committee resolution on 18 January 2018 that East Sussex County Council and Railfuture be invited to give a presentation to this meeting.

**Officers Recommendations:**

2. To note the presentation of Railfuture and participate in an open Q&A session to inform the continuing debate in relation to the reinstatement of the Lewes to Uckfield railway line, and invite discussion regarding their existing strategy and proposal.

**Reasons for Recommendation:**

3. To comply with the Scrutiny Committee's right to invite people outside of the Council to address it, discuss issues of local concern and/or answer questions as stated in the Council's Constitution with regard to the Attendance by Others (Part 4, rule 15).

**Information**

4. At its meeting on 17 October 2017, full Council had a debate in relation to the reinstatement of the Lewes to Uckfield railway line. The Council agreed the following motion as its recommendation:

*"Lewes District Council resolves to positively continue its long standing support for the much needed re-opening of the Lewes to Uckfield railway line and the Council asks the Scrutiny Committee to consider and propose what actions the Council and potential partner organisations might take to further this outcome."*

*This is something which hundreds of Lewes District residents have called for over many years, and it would be a strategic addition to the rail network for the Lewes District. This vital transportation link, especially if electrified, would help Lewes District Council meet their sustainable transport aspirations. Other examples of successful projects along these lines include the Borders Railway line”.*

5. Following the recommendation above, the following three points were considered by the Scrutiny Committee on 18 January 2017 as areas which the Committee would benefit from receiving further information:
  - a) How the government may wish to proceed;
  - b) What the existing proposals were; and
  - c) How a project to improve the transport infrastructure in this part of East Sussex would be supported by key local & government sponsored bodies in the South East region.

It was resolved by the Scrutiny Committee that, before any scrutiny review was deemed necessary, representatives of East Sussex County Council and Railfuture would be invited to give a presentation covering this information and participate in a Q&A session open to all members of the Council at the next Scrutiny Committee meeting on 19 April 2018.

6. East Sussex County Council had rejected an invitation to the Scrutiny Committee meeting on 19 April 2018 with the following response:

*“...Thank you for your email and sorry for the delay in responding.*

*Further to the request from Lewes District Council’s Scrutiny Committee to attend their meeting on 19 April to discuss the Lewes – Uckfield railway line, unfortunately no-one is available to attend the meeting.*

*I would suggest it might be more appropriate to invite Network Rail, who are responsible for rail infrastructure, to be invited to the meeting to give their perspective...”*

Members to note that, as there was a delay in East Sussex County Council responding to their invitation; it was deemed too short notice to invite Network Rail to attend the Scrutiny Committee meeting on 19 April 2018.

7. On 29 November 2017 the Department for Transport published *Connecting People: a strategic vision for rail* (see background papers). The following extract is from section 2 ‘An Expanded Network’:

*“2.10 The rail projects underway and in development will restore lost connections and make new ones. The best projects will reflect the way our towns, cities and lives have changed in the last half century, and will recognise that new capacity will be needed in new places...”*

Following this, the Cabinet Member for Planning wrote a letter to the Secretary of State for Transport seeking further clarification regarding whether this strategy

anticipated a project to restore the lost connection between Lewes and Uckfield. This letter was sent on 22 February 2018 and can be seen at Appendix A. No response has yet been received.

8. Mr Roger Blake, *National Board Vice-Chair, London & South East regional branch* and Mr Chris Page *National Board Chair*, will present considerations to the Panel on behalf of Railfuture, and participate in an open Q&A session to inform the continuing debate in relation to the reinstatement of the Lewes to Uckfield railway line.

### **Financial Appraisal**

9. An annual budget of £1,000 is available to support the work of the Scrutiny Committee and its Scrutiny Panels. Any costs associated with the review proposed are expected to be minor, given that the research work can be carried out by Council staff.

### **Legal Implications**

10. In considering the recommendations of this report, the Committee should adhere to the Scrutiny Procedure Rules set out in part 4 of the Council's Constitution.

### **Risk Management Implications**

11. There is no requirement for an analysis of risk.

### **Equality Screening**

12. An equalities analysis exercise is not considered necessary at this stage. If the Committee decides to proceed with the review, an equality analysis would be undertaken as part of the review and would be reported along with the review findings.

Dear Mr Grayling

Lewes District Council welcomes the Government's commitment to meet the demand for more capacity on the rail network by restoring lost connections and identifying a new generation of schemes that unlock new housing or economic growth and offer value for money, as set out in 'Connecting people: a strategic vision for rail' presented to Parliament in November 2017.

As you will be aware, the re-instatement of the Lewes to Uckfield railway has long been supported by the District Council, together with Wealden District Council, East Sussex County Council, the local MPs for Lewes and Wealden, and a number of towns and parishes along the route.

The re-instatement of the Lewes to Uckfield railway has the potential to contribute to sustainable economic growth by improving accessibility to jobs, education and training, by reducing car journeys - and hence congestion and carbon emissions - and by providing an alternative route to the Brighton Main Line during engineering works.

We therefore welcome the Government's commitment to help partners and promoters find the support and expertise they need consider new ways of designing, funding and financing rail capacity and new lines. In this respect, we would be grateful for additional information on how the re-instatement of former railway lines not yet identified in 'Connecting People' will be considered.

# Imagine ...

- There never was a railway between Lewes and Uckfield. Would we build one now? What would the irresistible justification look like?
- If a case for linking Lewes and places south with Uckfield and places north - by rail - is sufficiently compelling, why hasn't it happened?
- Beware the definition of insanity!

# “It’s the economy, stupid!”

- Rail as a means of transport as a type of communication – always about the growth and prosperity of communities and individuals
- Growth-enabling investment – a question of scale
- Responding to local needs, embracing sub-regional needs
- City of Brighton & Hove ranked 20<sup>th</sup> GB conurbation by population, 15<sup>th</sup> by productivity
- Authority Monitoring Report 2016/17 notes Objectively-Assessed Housing Need 2010-30 at 30,000 new homes, only 13,000 within City
- The other 17,000 new homes – a problem, or an opportunity?

# Imagine ...

- “*Connecting Communities – Expanding Access to the Rail Network*” by ATOC in 2009 suggested a population of 15,000 (6,000 homes) as a guidance threshold for new/reopened rail lines/stations
- That’s very roughly about the size of a Lewes or an Uckfield today
- It’s also very roughly about one-third of the unmet housing need of your sub-regional economic centre which it cannot accommodate
- Will Districts including Lewes around that centre reluctantly accept, or actively embrace, their share of its growth?
- Railfuture suggests that the latter choice could be the game-changer for the prospects of a Lewes-Uckfield rail link

# There are alternatives ...

- The London and South Coast Rail Corridor Study was published a year ago and included '*A new approach to Lewes-Uckfield*'. It set us all an exam question: "What level of housing and employment growth along the Tunbridge Wells-Uckfield-Lewes-Brighton corridor would be needed in order to create viable demand levels and a viable funding package?" - Just over a year ago the private sector London and Southern Counties Railways Consortium met the Transport Secretary. While Railfuture welcomes the interest of private investors their feasibility study is still awaited. See <https://www.railfuture.org.uk/article1732>

- Recall that in mid-2016 MHCLG invited bids for 'garden villages' of up to 10,000 new homes, announced in early-2017
- Railfuture campaigning for new station for Welborne Garden Village of 6,000 new homes <http://www.welbornegardenvillage.co.uk/>
- Rail projects of any significance delivered with strong partnership of stakeholders. Lewes in alliance with other Councils, two LEPs, TfSE?

# Re-imagine...

- Lewes-Uckfield as part of growth corridor, and rail line between them as an economic/housing growth enabler, not just transport scheme.
- Lewes/Eastbourne Councils ready to embrace a new paradigm, welcoming a sub-regional scale of new housing growth?
- Where to locate a scale of development sufficient to justify a rail link?
- Bottom line is almost certainly **No new growth = No new railway.**

## Request by Councillor for a Scrutiny Review - Guidance Notes

Members can request the Scrutiny Committee to hold a review into an important subject or matter of concern in the District. It need not relate purely to services provided by the Council and could cover any matter effecting local residents or businesses, as well as external organisations such as the Environment Agency.

And The Council focuses its scrutiny activities on the things that matter most and on outcomes that can make a real difference for local people. It simply has not got the resources to look at everything that might be suggested and therefore has to prioritise. The Council's suggested criteria for selecting reviews are as follows (this information is also contained within the Scrutiny Guide, which all members will have received a copy):

- Members identify key issue for the public
- Poor performing services
- High level of user dissatisfaction
- High level of resource in the area
- Government/council high priority area
- New government guidance or legislation
- Media attention

For each review undertaken there should be:

- Key reasons for undertaking the review
- What the review is expected to achieve
- Agreed measures for identifying a successful review
- A Scoping Report specifying the timetable and methodology (what evidence will be gathered, what consultation will take place)
- Consultation as to the composition of the panel which maybe undertaking the review

Please bear in mind when suggesting a topic for review that the following information will be needed and that where possible you provide as much information for the Scope and Terms of reference. This will assist the Chair when considering which three items will be selected for inclusion into the Annual Work Programme.

Scrutiny does not get involved in minor matters or individual concerns which are not of wider community significance. These need to be pursued through the appropriate Service Unit, Ward Councillors or Executive Member responsible. Nor does scrutiny deal with individual complaints which are dealt with through the Council's complaints procedure. Other topics not appropriate for scrutiny include: matters already being addressed, matters prejudicial to the Council's interests, individual disciplinary or grievance matters and matters unlikely to result in improvements for local people.
