Live Music.

Monday to Sunday. 23:00hrs – 00:00hrs (midnight)

On up to 15 occasions per calendar year until 2am the following morning.

Recorded Music.

Monday to Sunday. 23:00hrs – 00:00hrs (midnight)

On up to 15 occasions per calendar year until 2am the following morning.

Late Night Refreshment.

Monday to Sunday. 23:00hrs – 00:00hrs (midnight)

On up to 15 occasions per calendar year until 2am the following morning.

Supply of Alcohol.

Monday to Sunday. 10:00hrs – 00:00hrs (midnight)

On up to 15 occasions per calendar year until 2am the following morning.

The non-standard extension of hours to accommodate special 'blockbuster' screenings and other special films or films connected with special occasions such as Halloween.

Special screenings will be ticket only events.

Sussex Police in this case have no objections to the grant of a premises licence and ask that all the steps to be taken by the applicant to promote the licensing objectives, as recorded within Sect. M of the application, are transferred to the premises licence, if granted.

I would be grateful for a copy of the premises licence when issued.
