#### 1 <u>Introduction</u>

- 1.1 Eastbourne Borough Council received an application for a new Premises Licence under the Licensing Act 2003 for Chef H at 27-31 Langney Road, Eastbourne BN21 3QA from Latin Borisov, made on his behalf by his agent Ziya Merton. The application is included along with the plan of the premises at **Appendix 1.**
- 1.2 This premise hold's a Premises Licence under the Licensing Act 2003, the current licence was suspended in October 2019 due to non-payment of the annual fees. This licence will remain as a suspended licence until it is surrendered by the current licence holders.

#### 2 The Application

2.1 An application for the grant of a new premises licence under the Licensing Act 2003 for the following licensable activities:

Late night refreshment (indoor and outdoor)

Monday -Saturday 23:00-04:00

#### Supply of alcohol (off the premises)

Monday- Sunday 11:00- 23:00

#### **Opening Hours**

Monday- Saturday 11:00-04:00

Sunday 11:00- 23:00

#### 3 <u>Licensing Objectives</u>

3.1 When applying for a new premises licence under the Licensing Act 2003, the applicant is required to describe any steps they intend to take to promote the four Licensing Objectives as defined by the Licensing Act 2003. The Operating Schedule detailing these steps can be seen in the application form. This is included at **Appendix 1**.

#### 4 Consultation Process

- 4.1 The Licensing Act 2003 requires applicants to advertise both on the premises and in a local newspaper in order to inform the public of the application. The application details are also advertised on the council's website. Several "Responsible Authorities" have also been consulted as part of the process. There was a consultation period of 28 days, from 21st January 2021 to the 18th February 2021, for representations to be made, the applicant conformed with all the requirements as laid out within the The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005.
- 4.2 During the consultation process Sussex Police have submitted a representation based around the Premises being located within the Cumulative Impact Zone and their concerns that the Premises would not effectively promote the Licensing objectives. A copy of this representation is included at **Appendix 2**.
- 4.3 Eastbourne Borough Councils Licensing team have submitted a representation based around the Cumulative Impact Zone. A copy of this email is included at **Appendix 3**.
- There have also been four representations submitted by interested parties. These are included at **Appendix 4 to 7.**

#### 5 The Decision Making Process - The Licensing Objectives

5.1 In their decision making, the Licensing Sub-Committee must act to promote the four Licensing Objectives. All carry equal weight as part of the process. The Licensing Objectives are:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

A representation is a 'relevant representation' if it is about the likely effect of the grant of the licence on the promotion of the licensing objectives. The objector must establish that such a consequence is a *likely* effect of a grant (i.e. more probable than not).

# 6 <u>Eastbourne Borough Council's Statement of Licensing Policy & Section</u> 182 Guidance

- 6.1 Copies of the Council's Statement of Licensing Policy have previously been circulated to Members. A copy is also retained in the Members' Room.
- 6.2 Whilst each application will be considered on its merits, the Licensing Sub-Committee will act to promote the four licensing objectives and have due regard to:
  - Eastbourne Borough Council's Statement of Licensing Policy 2019 2024.
  - Section 182 Guidance issued by the Home Office.
- 6.3 Eastbourne Borough Council's Statement of Licensing Policy outlines the matters that the Authority will consider when determining matters under the Licensing Act 2003. An overview appears below.

#### 6.4 The Prevention Of Crime and Disorder

The Council's Statement of Licensing Policy states that the Operating Schedule should include steps to ensure the deterrence and prevention of crime and disorder on and in the vicinity of premises. The restriction of types of licensable activity, hours and imposition of conditions may be considered and applied as appropriate.

#### 6.5 Public Safety

The Statement of Licensing Policy states that the Operating Schedule should include steps to ensure the physical safety of patrons. This might include the imposition of conditions regarding capacity and mechanisms to promote responsible drinking. The restriction of types of licensable activity, hours and imposition of conditions may be considered and applied as appropriate.

#### 6.6 <u>Protection of children from harm</u>

The Statement of Licensing Policy requires that operating plans must specify the measures and management controls in place to protect children from harm. Conditions can be placed to restrict access to children to the premises during

certain times or when certain licensable activities are taking place. The restriction of types of licensable activity, hours and imposition of conditions may be considered and applied as appropriate.

#### 6.7 <u>Prevention of Public Nuisance</u>

The Statement of Licensing Policy states that within the Operating Schedule, applicants will be required to demonstrate how they intend to prevent nuisance arising, disturbance occurring and mechanisms to protect amenities. The restriction of types of licensable activity, hours and imposition of conditions may be considered and applied as appropriate.

#### 7 Cumulative Impact

- 7.1 The premises in question are located within the Cumulative Impact Zone. It is recognised that the impact of the number, type and density of licensed premises in a given area may lead to problems of noise, nuisance, crime and disorder outside of, or a distance from licensed premises.
- 7.2 Cumulative Impact is defined as the "potential impact upon the Licensing Objectives of a significant number of licensed premises concentrated in an area," and is a proper matter for consideration by the Licensing Authority.
- 7.3 The Licensing Authority may receive representations from a Responsible Authority or 'Interested Party' (any person) that the cumulative affect of licences is leading to an area becoming saturated. This creates exceptional problems of disorder and nuisance, over and above the impact from individual premises which undermines the promotion of one or more of the licensing objectives.
- 7.4 Where valid representations are received, the Cumulative Impact Policy creates a rebuttable presumption that the application will be refused.

It is for the applicant to address the Cumulative Impact Policy and produce evidence to demonstrate that the matter:

- (a) Will not add to the cumulative impact caused by licensed premises and challenges already experienced in the area;
- (b) Will not undermine the promotion of the Licensing Objectives.
- 7.5 The Cumulative Impact Policy clearly states that new licence applications and variations to existing licences, in the Zone should be refused, unless Members are satisfied that the applicant has provided evidence to show that premises will not exacerbate existing issues in the locality, or undermine the promotion of the Licensing Objectives.
- 7.6 It is stressed that the presumption to refuse an application does not relieve the Responsible Authority or anyone else making a representation of the need to provide supporting evidence in conjunction with a relevant representation. This must be submitted before the Licensing Authority may lawfully consider the effect of the Cumulative Impact Policy.

7.7 The Cumulative Impact Policy can be found within the Council's Statement of Licensing Policy 2019 – 2024.

#### 8 Representations

8.1 A copy of all the representations are included at **Appendix 2 to 7**, however a summary appears below:

#### 'Interested Parties'

Four representations have been received, generally based around crime and disorder and the public nuisance licensing objectives. It has been agreed that some of their personal details need not be supplied to the applicant as the Council accepts their justified concerns.

#### **Representations from Responsible Authorities**

The following summarises whether representations have been received from responsible authorities:

- Sussex Police Representation around the premises being based within the CIZ.
- Eastbourne Borough Council (Specialist Advisor) Environmental Health
   No representation
- Eastbourne Borough Council (Specialist Advisor) Health and Safety No representation.
- Eastbourne Borough Council (Specialist Advisor) Planning No representation.
- Eastbourne Borough Council (Specialist Advisor) Licensing –
   Representation around the premises being based within the CIZ
- East Sussex Fire and Rescue Service No representation
- Area Child Protection Team No representations
- Trading Standards (East Sussex County Council) No representation.
- Primary Care Trust- No representation
- 8.2 On the basis of the representations, it is considered unlikely that this application will be successfully mediated before the Sub-Committee hearing.

#### 9 Options open to the Sub-Committee

- 9.1 The Licensing Sub-Committee shall take the steps it considers appropriate for the promotion of the Licensing Objections and may;
  - Grant the Licence in the same terms as it was applied for.
  - Grant the Licence, but modify the conditions as appropriate for the promotion of the licencing objectives
  - Grant the Licence, but modify the hours of licensable activity as appropriate for the promotion of the licensing objectives
  - Reject the application.
- 9.2 The Sub-Committee are asked to note the procedures relating to this hearing which are contained in The Licensing Act 2003 (Hearing) Regulations 2005 as

amended.

- 9.3 The Sub-Committee may also consider any other matters that may negatively impact upon the Licensing Objectives and exercise their powers to impose conditions, or take the appropriate action as they see fit, in order to promote the Licensing Objectives
- 9.4 In determining what, if any, conditions should be attached to a licence, these should only be imposed where it is considered appropriate and proportionate on a case by case basis. The applicant, any person or any Responsible Authorities may also suggest conditions to address concerns as a means to promote the Licensing Objectives. The Sub-Committee may not impose any condition unless its discretion has been exercised following receipt of a relevant representation and is satisfied that it is appropriate to promote one or more of the licensing objectives.

#### 10 <u>Legal Considerations</u>

- 10.1 Under section 18 Licensing Act 2003 (as amended), following receipt of an application for a premises licence if relevant representations are received, and unless all parties agreed that a hearing is unnecessary, then the Licensing Authority must hold a hearing. At the hearing the Sub Committee shall having regard to the representations take such steps as it considers appropriate for the promotion of the licensing objectives. The relevant options are outlined in para 9.1 of this Report.
- The Licensing Sub Committee should be mindful of requirements and responsibilities placed on them by other legislation, in addition to those contained within the 2003 Act. These include, but are not limited to, having due regard to the Equality Act 2010 and the Human Rights Act 1998.
- 10.3 The Legal Section considered this Report on 2 March 2021 (Iken-9899-EBC-MW)

#### 11 Right of Appeal

11.1 Under section 81 and Schedule 5 of the 2003 Act there is a right of appeal to the Magistrates' Court in respect of applications for new licences. This right of appeal is open both to the applicant and to any person who has made relevant representations. The appeal application must be made within 21 days of the written notification of the Sub Committee's decision.

#### 12 Financial Appraisal

- 12.1 The cost of delivering the licensing function is fully covered by the Licensing fees.
- 12.2 A decision made by the Sub Committee may be appealed by any party to the proceedings to a Magistrates' Court. Costs associated with this matter and incurred by any party, may in certain circumstances be awarded against the Council.

#### 13 Risk management implications

13.1 There are no risks associated with the content of this report.

#### 14 **Equalities & Fairness Screening**

14.1 An Equality Analysis is not constructive in this instance.

# **a) General – all four licensing objectives (b, c, d and e)** (please read guidance note 10)

The supply of alcohol will not be made under the Premises Licence:-

At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or

At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended

Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence

An age verification policy will be adopted in respect of the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to be under 18 years of age (or 25 to be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either (i) a holographic mark or (ii) an ultraviolet feature.

#### b) The prevention of crime and disorder

Digital CCTV and appropriate recording equipment to be installed in accordance with Home Office guidelines, operated and maintained throughout the premises internally and externally to cover all public areas, including the entrance to the premises. The system shall be on and recording at all times the premises licence is in operation.

CCTV footage will be stored for a minimum of 31 days.

The management will give full and immediate cooperation and technical assistance to the Police in the event that CCTV footage is required for the prevention and detection of a suspected or alleged crime.

The CCTV images will record and display dates and times and these times will be checked regulary to ensure their accuracy.

Any breakdown or system failure will be notified to the police immediately and remedied as soon as practicable.

An incident log will be maintained by the premises showing a detailed note of incidents that occur in the premises. The log book shall be kept on the premises and be available for inspection at all times the premises are open by authorised officers and staff of the Licensing Authority or the Police.

If required, SIA registered door staff can be employed to be on duty for the latter part of the evening and into the early hours.

Alcohol deliveries will only be made to a residential or business address and not to a public place.

The age verification policy will be clearly advertised at each stage of the order and on all advertising. Customers will be reminded that it is a criminal offence for a person under 18 to purchase or attempt to purchase alcohol and that it is also an offence to purchase alcohol on behalf of a person aged under 18.

At the time the order is placed, a declaration will be required from the person placing the order that that person is aged over 18 years of age and that the intended recipient are over 18 years of age.

Where the premises contracts a third party to deliver alcohol on their behalf, and the person collecting the alcohol from the premises delivers it directly to the customer within a short timescale (such as Deliveroo, Just Eat) the premises will ensure that the third party only employs delivery employees or agents over 18 and over, is aware that alcohol is included in the delivery, the the delivery person actively engages with the person receiving delivery and operates a challenge 25 policy rather than just handing the delivery over, and that in the event that the recipient of the alcohol is challenged for ID and does not provide appropriate and valid ID, the delivery person will retain the alcohol and return it to the premises.

All off sales of alcohol will be made in sealed containers.

#### c) Public safety

There will be a first aid kit kept and maintained at the premises.

There will be a log book present on the premises for recording any incident and will be available on request to the local Police or a local authority licensing agent.

The premises licence holder will ensure that the appropriate fire safety and health and safety regulations are applied at the premises.

#### d) The prevention of public nuisance

Appropriate signage will be displayed at all exits requesting patrons to respect the needs of local residents and leave quietly.

All deliveries to the premises will take place at a time as to not cause a disturbance to the nearby residents.

Waste collections will be arranged for such a time as not to cause a nuisance to the nearby residents.

Waste will be kept securely in a designated area and the movement of bins and rubbish shall be kept to a minimum at all times to reduce the levels of noise produced by the premises.

#### e) The protection of children from harm

A Challenge 25 policy will be adopted, whereby any person that appears to be under the age of 25 years of age must prove they are over 18 by providing identification, bearing their photograph, date of birth, and a holographic mark and/or ultraviolet feature. Examples of appropriate identification include a passport, photocard driving licence, military ID, proof of age card bearing the PASS hologram and biometric residence permit.

All refusals will be entered into the refusals book.

Signs will be displayed informing customers that a Challenge 25 policy is in operation at the premises.







# RE; APPLICATION FOR CHEF H, 27-31 LANGNEY ROAD EASTBOURNE BN21 3QA, UNDER THE LICENSING ACT 2003.

I write on behalf of the Chief Officer of Police for Sussex to raise a representation against the grant of the above application on the grounds that it will undermine the Licensing Objectives of the prevention of crime and disorder, the prevention of public nuisance and public safety.

This is a proposed licence in an area of Eastbourne which is subject to a Special Policy adopted by Eastbourne Borough Council (EBC). The premises lies within the Cumulative Impact Zone (as defined in the EBC statement of Licensing Policy 2019-2024)

Paragraph 8.1 of Eastbourne Borough Councils statement of Licensing Policy 2019-2024 states; The impact of the number, type and density of licensed premises in a given area may lead to problems of noise, nuisance, crime and disorder outside of, or a distance from licensed premises. Cumulative Impact is defined as the "potential impact upon the Licensing Objectives of a significant number of licensed premises concentrated in an area," and is a proper matter for consideration by the Licensing Authority.

The applicant describes the nature of premises as "Licensed restaurant with take away and delivery facility" and seeks the following licensable activities and timings;

- Late Night Refreshment Monday to Saturday 2300-0400
- Supply of alcohol Monday to Sunday 1100-2300

Paragraph 14.24 of the Secretary of State's Guidance to the Licensing Act 2003 (April 2018) provides:

"A cumulative impact assessment (CIA) may be published by a licensing authority to help it to limit the number or types of licence applications granted in areas where there is evidence to show that the number or density of licensed premises in the area is having a cumulative impact and leading to problems which are undermining the licensing objectives. CIAs relate to applications for new premises licences and club premises certificates and applications to vary existing premises licence and club premises certificates in a specified area."

Paragraph 14.40 of the Secretary of State's Guidance to the Licensing Act 2003 (April 2018) provides:

'In publishing a CIA a licensing authority is setting down a strong statement of intent about its approach to considering applications for the grant or variation of premises licences or club premises certificates in the area described....

Applications in areas covered by a CIA should therefore give consideration to potential cumulative impact issues when setting out the steps that will be taken to promote the licensing objectives'

The applicant has not referred to the Cumulative Impact Policy (CIP) or the EBC statement of Licensing in their application. Although the applicant has offered a number of conditions, Sussex Police do not believe these go far enough to help mitigate any potential risk in what is already a very busy area of Eastbourne.

On Tuesday 26<sup>th</sup> January 2021, Sussex Police Licensing contacted Euro Safety, who are the agents acting on behalf of the applicant. They were made aware of our concerns about the premises operating times and how they have not provided enough evidence of how the premises will promote the four licensing objectives. The agent said he had partially read EBC statement of licencing but when questioned did not know anything about the CIP. It was explained how they needed to provide details of how the premises will not negatively impact one or more of the Four Licensing Objectives. The agent's response was to ask for Police to provide them with conditions and they will agree to them. This response does not provide Sussex Police with confidence that this premises will be manged efficiently.

The night time economy within Eastbourne can at times be very challenging for all the emergency services and the CIA has been shown to be a hot spot location within Eastbourne for crime and violent offences. There are already a high number of late night licensed venues all of which are in very close proximity to this new proposed venue and yet another late night establishment is likely to negatively add to the cumulative impact which in turn is likely to undermine the licensing objectives.

In light of the above together with data showing an increase in Sexual assault within the Cumulative area, Sussex Police are not satisfied that this application presents an exceptional case to override the presumption of rebuttal for new applications within the CIA. We invite the Licensing Authority to seriously consider refusing this application.

I am writing on behalf of the Licensing Authority for Eastbourne Borough Council as a Responsible Authority under the Licensing Act 2003.

I am responding to an Application for a Premises Licence submitted to Eastbourne Borough Council by Latin Borisov for a premise at Chef H, 27-31 Langney Road, Eastbourne, BN21 3QA

This premises is situated within the Cumulative Impact Zone as defined in the Licensing Policy for Eastbourne Borough Council. The Cumulative Impact Assessment for the Licensing Policy was fully considered and reviewed through Public Consultation in March 2019. The Licensing Authority has not been made aware of any changes necessitating a downgrading of that assessment.

This is a representation against the application.

The grounds for this representation are that the application does not address the Cumulative Impact Assessment of the Eastbourne Borough Council Licensing Policy, Appendix 2 – Section 5

In addition, it is our view that if the Premises Licence is granted in the form applied for, it will undermine the licensing objectives of Prevention of Crime and Disorder, Prevention of a Public Nuisance and Protection of Children from Harm. The premises appears to be a fast food restaurant with a take away facility until 4am. It will of its nature attract a specific demographic particularly after late night bars and clubs have closed.

The Licensing Authority implies no adverse comment about the premises or its intended clientele. It merely seeks to point out the nature of the site and the fact that the applicants have significantly underplayed this and failed to address it in their Operating Schedule. The Operating Schedule makes no mention of the Cumulative Impact Zone, nor does it acknowledge the position of the premises in one of the busiest and well-known tourist destinations in the UK.

# Operating Schedule.

# <u>General</u>

The information contained here is not site specific. It simply states what the Licensing Act requires for licensable activities to take place.

In our view little thought has been given to providing overall details of how the Premises Licence Holder and the DPS will promote the licensing objectives. It is a generic set of comments that provide no useful information as to how the business will promote the licensing objectives.

Nothing here addresses the particular nature of the venue or takes account of the Cumulative Impact Assessment.

# Prevention of Crime and Disorder

The Licensing Authority notes the intention to provide CCTV and the conditions attached to this. We expect this condition to be included on the Premises Licence should it be granted.

The Premises Licence Holder is applying for the sale of alcohol for consumption off the premises.

We note that there are a number of proposed conditions relating to the delivery of alcohol. If the licence is granted, we expect these to be added as conditions for this licensable activity.

The application makes no mention of sale of alcohol at the site to customers attending in person.

Is it the intention of the business to sell alcohol for consumption off site in such circumstances? Will alcohol be sold without a purchase of food?

Does the business intend to display alcohol at the site?

We note the premises is a restaurant/ take away food store and are concerned that no mention is made of controlling alcohol as described.

#### SIA Staff

The Licensing Authority notes the following information in the application:

'SIA registered door staff can be employed to be on duty for the latter part of the evening and into the early hours'

We are aware of a conversation between Sussex Police and the applicant's agents. It is surprising that the agents have not fully read the Licensing Policy for Eastbourne Borough Council and were not aware of the Cumulative Impact Zone.

If the application is granted this premises will be open until 4am serving food. It is in close proximity to other such establishments and importantly to a number of late-night venues licensed for music dancing and the sale of alcohol.

Experience tells us that food outlets in this location are very busy during the early hours of the morning with people who have been drinking in the late venues. This has the potential for customers acting irrationally, resulting in crime and disorder.

We note the conditions for CCTV and delivery of alcohol. However, little thought has been given to the practicalities of operating this premises and consider the comments about SIA staff to confirm this. It is little short of dismissive of this licensing objective.

# Prevention of a Public Nuisance

The Licensing Authority notes the intention to time restrict deliveries and waste collections. although the latter may be dictated by contractors. It also notes the intention to secure waste and keep movement of waste to a minimum.

Despite this the overall impression is that these are generic conditions and not site specific.

## Protection of Children from Harm

The Licensing Authority notes the proposed conditions regarding an Age Verification Policy and expect these to be included should the application be granted. There are still concerns about the sale of alcohol at the site, its display and whether its with or without food.

## Overall

- 1. The Licensing Authority has grave concerns that an application such as this is made with no reference to or mention of the Cumulative Impact Assessment.
- 2. That is not surprising when it is discovered the agents are not even aware of the Cumulative Impact Assessment.
- 3. The application is couched in generic terms and not site specific.
- 4. Comments made by the agent to Sussex Police "send us your conditions and we will agree to them" display an arrogance and a flippancy to the nature of the application. At the very least we expect some engagement by the agents and offers of conditions that can form the basis of a discussion.
- 5. It is our view that if the Premises Licence is granted in the form applied for, it will undermine the licensing objectives of Prevention of Crime and Disorder, Prevention of a Public Nuisance and Protection of Children from Harm.

I am contacting your department for my objection to the proposed changes to the premises licence for Chef H 27-31 Langney Rd BN21 3QA, to extend trading hours to 04.00am with off sales of alcohol, both being new changes to the former licence. The premises is situated in an area covered by the Special Saturation Policy ,which already has a high volume of licensed premises. Residential flats are now situated above Chef H as well as family accommodation in the vicinity. It is a Human Right to an undisturbed nights sleep, which trading to 04.00 would only exacerbate.

Having lived in the area for 26 years, I have witnessed problems in the past connected to late night alcohol related issues. The following, Fighting , Violent outbreaks due to intoxicated groups not dispersing, unacceptable noise levels from speeding cars, criminal damage to vehicles ,Human excrement and vomit in residents doorways/alleys due to lack of toilet facilities, Litter from takeaways left on front steps.

In previous occasions I have had full support of local residents telling me about the above problems when they signed a petition regarding late licence issues. Due to covid this is not possible this time. The proposed application for extended trading hours /off sales alcohol will only increase the above incidences , especially when covid restrictions are lifted. These late night problems will cause unnecessary use of the Emergency services.

The approval of this application would then set a precedence for other business to follow suit .I do not have an objection to the opening of Chef H, as it is good to see an empty premises back trading, but closing hours in line with adjacent eateries/takeaways, sympathetic to the wellbeing of local residents.

I have raised my concerns to Adrian Ley, chairman of the town centre Panel Association and contacted my local councillor.

Hello, to whom it may concern, I rang the council on Friday 29th January to ask for some information and advice with regards to objecting a planning application for the premises called Chef H fast food factory. I have seen a sign in their door window that says they are applying for a license act and that they want to open until 4am in the morning Monday to Saturday and 11pm Sunday. There is no application number on the sign and the only website they give is for planning applications not a website or link for objections, hence the reason I rang the council who told me to email you if I had no luck with the information on the sign. The reason I object to this proposal is because there are 10 residential flats above the Chef H premises. We already had a lot of trouble with noise issues and complaints when KFC were there and they closed at 11pm but were making noise until 1am and sometimes even later. So it is not viable for the residents in the flats to be able to live in some form of peace and quiet if they are going to sell alcohol and stay open until 4am. Already the KFC attracted some unruly people to this part of Langney Road, unfortunately the Cameo nightclub and all the other takeaways don't help the situation but we don't want it made worse. I therefore also object to the licensing act to sell alcohol being a residential dwelling place above the premises. I am attaching a photo of the form in Chef H window and would like to know if it is a valid one as there is no information on it with regards to application no and info where to object.

My objections against the application for selling alcohol and staying open until 4am in the morning, making sure they cover the relevant issues for the prevention of crime and disorder: this stretch of Langney Road does already suffer from the effects of crime and disorder where some people coming out from the local pubs and Cameo nightclub behave in a disorderly manner such as shouting, arguing, swearing, fighting, urinating and vomiting on a regular basis, shop windows have been smashed on numerous occasions and damage to vehicles which included my husbands twice, so another licensed establishment is only going to contribute in making it worse. I could understand if it was going to be a restaurant where you would have a glass of wine with your sit down meal like other restaurant establishments but Chef H is a takeaway food shop and it's seating area is like a McDonald's setup, and they don't sell alcohol or stay open until 4am and they have no residential flats above or surrounding them. The only premises I know of that sell alcohol are Cameo nightclub and the off licence on Langney Road, none of the other takeaways sell alcohol. The KFC which was there previously did not sell alcohol. With regards to: Prevention of nuisance, the KFC used to close at 11pm Mon to sat and 10/10.30pm sun and they were very inconsiderate when it came to noise as they would congregate outside their back yard area having cigarette breaks and talking loudly /laughing, throwing rubbish out by banging the bin lids multiple times until gone 1am etc late at night, my bedroom window overlooks this back vard area so did disturb my sleep on a daily basis, my kitchen window also overlooks this area and if my windows kitchen or bedroom are open then the fumes from smoking come inside our flat. Also the people coming out of the pubs and nightclubs congregate around the takeaway establishments late into the early hours of the morning where they get food from and when they have been drinking they are a public nuisance by shouting, swearing, fighting, arguing, urinating and vomiting around the premises etc. Therefore I feel it is not considerate to open until 4am with residential flats above. Given the noise KFC made and they closed at 11pm, it could be an option that they have cigarette /breaks out of their side door where the bins are also by leaving their bins outside the side of their shop instead of out the back would make a
