1 Introduction

- 1.1 Eastbourne Borough Council received an application for a new Premises Licence under the Licensing Act 2003 for Tesco Express, 83-85 Terminus Road, Eastbourne, BN21 3NJ from Tesco Stores Limited. The application is included at **Appendix 1**.
- 1.2 Alongside the application a plan of the premises was submitted, and this can be found at **Appendix 2**.
- 1.3 83-85 Terminus Road is a commercial premises on the main street in Eastbourne High Street. Previously occupied by the clothing shop Monsoon.

2 The Application

- 2.1 An application for the grant of a new premises licence under the Licensing Act 2003 for the following licensable activities:
- 2.2 Sale by Retail of Alcohol (Off the premises only) Every Day 06:00hrs until 00:00hrs.

2.3 Provision of Late Night Refreshment (Indoors only)

Every Day 23:00hrs until 00:00hrs.

2.4 **Opening Hours**

Every Day 06:00hrs until 00:00hrs.

2.5 **General Description**

Tesco is a large national operator with companywide policies and procedures. This premises is planned to be a Tesco Express of which there are currently many in Eastbourne.

3 Licensing Objectives

When applying for a new premises licence under the Licensing Act 2003, the applicant is required to describe any steps they intend to take to promote the four Licensing Objectives as defined by the Licensing Act 2003. The Operating Schedule detailing these steps can be seen in the application form. This is included at **Appendix 1**.

4 Consultation Process

- 4.1 The Licensing Act 2003 requires applicants to advertise both on the premises and in a local newspaper in order to inform the public of the application. The application details are also advertised on the council's website. Several "Responsible Authorities" have also been consulted as part of the process. There was a consultation period of 28 days, from the 8th September 2022 until midnight on the 5th October 2022, for representations to be made. The applicant conformed with all the requirements as laid out within The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005.
- During the consultation period one representation was made by a Responsible Authority, Sussex Police. This can be found at **Appendix 3**. Please note although the Police's Representation Letter states the 5th September, I have confirmed with them that this was indeed a typo and was instead meant to read the 5th October.
- Two more representations were received from members of the public. These can be found at **Appendix 4 and 5.**
- 4.4 Members are asked to note that not all the information provided within these representations is valid against the four Licensing Objectives within the Licensing Act 2003.

5 The Decision Making Process - The Licensing Objectives

- 5.1 In their decision making, the Licensing Sub-Committee must act to promote the four Licensing Objectives. All carry equal weight as part of the process. The Licensing Objectives are:
 - The Prevention of Crime and Disorder
 - Public Safety

- The prevention of Public Nuisance
- The Protection of children from Harm.
- A representation is a 'relevant representation' if it is about the likely effect of the grant of the licence on the promotion of the licensing objectives. The objector must establish that such a consequence is a likely effect of a grant (i.e., more probable than not).

6 Eastbourne Borough Council's Statement of Licensing Policy & Section 182 Guidance

- 6.1 Copies of the Council's Statement of Licensing Policy have previously been circulated to Members. A copy is also retained in the Members' Room.
- 6.2 Whilst each application will be considered on its merits, the Licensing Sub-Committee will act to promote the four licensing objectives and have due regard to:
 - Eastbourne Borough Council's Statement of Licensing Policy 2019 -2024.
 - Section 182 Guidance issued by the Home Office.

Eastbourne Borough Council's Statement of Licensing Policy outlines the matters that the Authority will consider when determining matters under the Licensing Act 2003.

6.3 Members are asked to consider, in particular, section 12 Prevention of Crime and Disorder and section 14 Prevention of Public Nuisance of the Statement of Licensing Policy when making a decision on this application.

7 Representations

- 7.1 A copy of the representations are included at **Appendix 3, 4 and 5.**
- The applicant was unable to come to an agreement with Sussex Police after the Police had asked the Applicant to vary the store closing times from 23.00hrs to 22.00hrs and, to have SIA staff present at the premises door from 20.00hrs on a Friday, Saturday and Bank Holidays. It was not deemed productive to try to mediate with the other representators.
- 7.3 **Two** representations have been received, these representators have made comments under Prevention of Public Nuisance and Crime and Disorder.
- 7.4 The following summarises whether representations have been received from responsible authorities:
 - **Sussex Police** Representation received, relating to Prevention of Crime and Disorder and Public Nuisance.
 - Eastbourne Borough Council (Specialist Advisor) Environmental Health - No representation.

- Eastbourne Borough Council (Specialist Advisor) Health and Safety No representation.
- Eastbourne Borough Council (Specialist Advisor) Planning -No representation.
- Eastbourne Borough Council (Specialist Advisor) Licensing -No representation.
- East Sussex Fire and Rescue Service No representation.
- Area Child Protection Team No representations.
- Trading Standards (East Sussex County Council) No representation.
- Primary Care Trust No representation.

8 Options open to the Sub-Committee

- 8.1 The Licensing Sub-Committee shall take the steps it considers appropriate for the promotion of the Licensing Objections and may:
 - Grant the Licence in the same terms as it was applied for.
 - Grant the Licence but modify the conditions as appropriate for the promotion of the licencing objectives.
 - Grant the Licence but modify the hours of licensable activity as appropriate for the promotion of the licensing objectives.
 - Reject the application.
- The Sub-Committee are asked to note the procedures relating to this hearing which are contained in The Licensing Act 2003 (Hearing) Regulations 2005 as amended.
- 8.3 The Sub-Committee may also consider any other matters that may negatively impact upon the Licensing Objectives and exercise their powers to impose conditions, or take the appropriate action as they see fit, in order to promote the Licensing Objectives.
- 8.4 In determining what, if any, conditions should be attached to a licence, these should only be imposed where it is considered appropriate and proportionate on a case-by-case basis. The applicant, any person or any Responsible Authorities may also suggest conditions to address concerns as a means to promote the Licensing Objectives. The Sub-Committee may not impose any condition unless its discretion has been exercised following receipt of a relevant representation and is satisfied that it is appropriate to promote one or more of the licensing objectives.

9 Financial appraisal

- 9.1 There are no specific financial implications arising from this application as the cost of delivering the licensing function is fully covered by the Licensing fees.
- 9.2 A decision made by the Sub Committee may be appealed by any party to the proceedings to a Magistrates' Court. Costs associated with this matter and incurred by any party, may in certain circumstances be awarded against the

Council. The impact of these additional costs (if any) will therefore need to be met from within existing revenue budgets.

10 Legal implications

- 10.1 Under section 18 Licensing Act 2003 (as amended), following receipt of an application for a premises licence if relevant representations are received, unless all parties agree that a hearing is unnecessary, the Licensing Authority must hold a hearing. At the hearing the Sub Committee shall, having regard to the representation, take such steps as it considers appropriate for the promotion of the licensing objectives. The relevant options are outlined in para. 8.1 of this Report.
- The Licensing Sub Committee should be mindful of requirements and responsibilities placed on them by other legislation, in addition to those contained within the Licensing Act 2003. These include, but are not limited to, having due regard to the Equality Act 2020, the Human Rights Act 1998 and the Crime and Disorder Act 1998.
- 10.3 Under section 181 and Schedule 5 Licensing Act 2003 there is a right of appeal to the Magistrates' Court in respect of applications for new licences. This right of appeal is open both to the applicant and to any person who has made relevant representations. The appeal application must be made within 21 days of the written notification of the Sub Committee's decision to the appellant.
- 10.4 The Legal section considered this Report on 21 October 2022 (IKEN 11419-EBC-MW).

a) General – all four licensing objectives (b, c, d, and e) (please read guidance note 10)

Tesco is a large national operator with a range of head office and local support. The company has devised policies, procedures, systems, and training to ensure that they sell alcohol in a responsible manner.

There is a detailed programme which ensures that comprehensive training is provided to employees having regard to their role and the responsibilities and such training is regularly reviewed, and records kept.

b) The prevention of crime and disorder

We will have a digital CCTV system that covers the premises, including the main area which will be used for display of alcohol. Images will be retained for 31 days.

A member of the management team will be on the premises all the time the store is open. This colleague will have responsibility for the premises and will be the initial point of contact for any issues that may arise.

c) Public safety

The premises licence holder is fully aware of its responsibilities under a range of health and safety related legislation and has policies and procedures in place to be confident of complying with the relevant obligations which arise.

d) The prevention of public nuisance

The company has a "good neighbour" ethos which seeks to ensure that the premises plays an active part in the local community.

e) The protection of children from harm

The premises will operate a Think 25 policy. The checkouts will be programmed to prompt the customer assistant when an alcohol product is scanned at the checkout to follow the Think 25 policy.

All colleagues will receive training in relation to the underlying law and Tesco policy, systems, and procedures. This training will be documented, and refresher training will be provided on a regular basis.





Notice of objection is hereby given on behalf of the Chief Officer of Police for Sussex for the above premises license on the grounds of the licensing objectives: of prevention of crime and disorder and public nuisance.

Sussex Police received the application on 08th September 2022, which seeks to licence the provision of late night refreshment (indoors) on the following days: Monday-Sunday 23:00-00:00 and the sale by retail of alcohol for consumption off the premises on the following days: Monday-Sunday 06:00-00:00

Sussex Police's rationale for objecting to this application seeks to cease trading including the sale of alcohol at 00:00. Sussex Police proposed on 15th September 2022 the store closing at 22:00 would be more justified for the location and the current crime and disorder in the area. The store is located in a high harm hotspot for public place violent crime and street drinking causing a significant impact on Ant-Social Behaviour in the area which does include littering and urinating in public places.

The location is covered by a Public Space Protection Order to tackle street drinking and its associated anti-social behaviour and public place violent crime. The store is located where the street community frequent regularly.

Sussex Police proposed on 15th September 2022 that SIA to be present at the premises door from 20:00 on a Friday, Saturday and Bank Holidays.

For the Postcode Search of BN21 3NJ, within a 0.15 mile radius, over the space of a year – this being from 01/09/2021 – 30/09/2022 741 incidences had been recorded 467 of those as 'violence against a person' 154 as 'public order' 41 as 'sexual offences' 20 as 'drug offences' 38 as 'arsons and criminal damage' 11 as 'possession of offences weapons' and 10 as 'miscellaneous crimes against society'. Friday 22:00-23:00 there are 13 incidences of 'violence's against a person'. Saturday there are 12 incidents of 'violence against a person' and Friday – Saturday there are 3 incidences of 'sexual offences' between 2200-2300.

The area also attract a significant shoplifting, searching over the same period of time as above, there were 265 recorded incidences of theft, the highest number being recorded on Saturdays.

The applicant has not;

yet wished to comment on this proposed condition until she had secured some data regarding this, however this data has still not been supplied to Sussex Police, as true at the time of writing this letter (05th September 2022)

All points relate to crime and disorder, along with to a degree a nuisance. I am fully aware of what the licensing objectives are.

By having alcohol available in this location during the proposed hours 0600 - 0000 with the other activities that occur here it will encourage individuals with addictions to frequent this location and inevitably target the store. Having worked in the town centre for 16 years and frequent the town centre on a daily basis, I feel I am far more acutely aware of how this will impact the town than yourself. You are aware that this location is where addicts often with alcohol and drug addictions wait in the mornings prior to going to pharmacies for their medication?

By having too many convenience stores that sell alcohol within close proximity will in fact hinder any attempts to prevent crime and disorder, therefore this is a valid point and does fit within the licensing criteria.

If you could elude to what else you feel can't be included that would be grateful, it would have been useful to detail it in your response rather than be vague.

I wish to strongly object to the application by Tesco Ltd for a licence to sell alcohol between the hours of 0600 - 0000 from their new outlet in Terminus Road, Eastbourne.

Given that there is already a serious problem regarding anti-social behaviour in the town centre, fuelled by alcohol and obvious drug use, it would be beyond comprehension that a licence could be granted that would make access to alcoholic drinks so freely available from very early in the morning until late at night.

I have myself witnessed very threatening behaviour in this section of Terminus Road, which had all the hallmarks of being exacerbated by alcohol and/or drug abuse.

The Licensing Authority must put both the safety of the public and their right to a pleasant experience in Eastbourne town centre as the No.1 priority when considering this issue.
