1 Introduction

1.1 Eastbourne Borough Council received an application for a variation of a premises licence under the Licensing Act 2003 for Glass House Royal Parade Eastbourne BN22 7QA by Shoes Simes.

The application is at **Appendix 1**, the plan is at **Appendix 2** and the current premises licence is at **Appendix 3**.

2 The Application

3 Licensing Objectives

When applying for a variation of a premises licence under the Licensing Act 2003, the applicant is required to describe any steps they intend to take to promote the four Licensing Objectives as defined by the Licensing Act 2003. The Operating Schedule detailing these steps can be seen in the application form. This is included at **Appendix 1**.

4 Consultation Process

- 4.1 The Licensing Act 2003 requires applicants to advertise both on the premises and in a local newspaper in order to inform the public of the application. The application details are also advertised on the council's website. Several "Responsible Authorities" have also been consulted as part of the process. There was a consultation period of 28 days, from 12 June 2023 to the 10 July 2023, for representations to be made. The applicant conformed with all the requirements as laid out within The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005.
- There have been 27 representations against the application and 7 supporting representations for the application by residents and local businesses. These were under the Licensing Objectives of Prevention of Public Nuisance and Prevention of Crime & Disorder. These are included at **Appendix 4.**
- 4.3 Members are asked to note that not all the information provided within the representations are valid against the four Licensing Objectives within the Licensing Act 2003.

5 The Decision Making Process - The Licensing Objectives

- 5.1 In its decision making, the Licensing Sub-Committee must act to promote the four Licensing Objectives. All carry equal weight as part of the process. The Licensing Objectives are:
 - The Prevention of Crime and Disorder
 - Public Safety
 - The Prevention of Public Nuisance
 - The Protection of Children from Harm
- A representation is a 'relevant representation' if it is about the likely effect of the grant of the licence on the promotion of the licensing objectives. The objector must establish that such a consequence is a likely effect of a grant (i.e. more probable than not).

6 Eastbourne Borough Council's Statement of Licensing Policy & Section 182 Guidance

6.1 Whilst each application will be considered on its merits, the Licensing Sub-Committee should act to promote the four licensing objectives and have due regard to:

- Eastbourne Borough Council's <u>Statement of Licensing Policy 2019 2024</u>. (in particular parts 11 & 13)
- <u>Section 182 Guidance issued by the Home Office</u>. (in particular parts 8 & 9)

7 Representations

- 7.1 A copy of the representations is included at **Appendix 4**.
- 7.2 Two mediation meetings were held between the applicant, local businesses and local residents. At the time of writing this report no compromise had been reached.

8 Options open to the Sub-Committee

- 8.1 The Licensing Sub-Committee shall take the steps it considers appropriate for the promotion of the Licensing Objections and may:
 - Modify the conditions on the licence
 - Modify the hours of licensable activity
 - Reject the whole of the application
 - Reject part of the application
- 8.2 The Sub-Committee are asked to note the procedures relating to this hearing which are contained in The Licensing Act 2003 (Hearing) Regulations 2005, as amended.
- 8.3 In determining what, if any, conditions should be attached to a licence, these should only be imposed where it is considered appropriate and proportionate on a case-by-case basis.
- The applicant, any person or any Responsible Authorities may also suggest conditions to address concerns as a means to promote the Licensing Objectives.
- 8.5 The Sub-Committee may not impose any condition unless its discretion has been exercised following receipt of a relevant representation.

9 Financial appraisal

- 9.1 The cost of delivering the licensing function is fully covered by the Licensing fees.
- 9.2 A decision made by the Sub Committee may be appealed by any party to the proceedings to a Magistrates' Court. Costs associated with this matter and incurred by any party, may in certain circumstances be awarded against the Council. The impact of these additional costs (if any) will therefore need to be met from within existing revenue budgets.

10 Legal implications

- 10.1 Under section 34 the Licensing Act 2003, a holder of a premises licence may apply to the Licensing Authority for a variation of a licence, in certain circumstances. Under section 35, when relevant representations are made during the consultation period the Authority must hold a hearing to consider the representations and having regard to those representations take such steps as it considers appropriate for the promotion of the licensing objectives.
- 10.2 Under section 181 and Schedule 5 (4) 2003 Act there is a right of appeal to the Magistrates' Court within 21 days of the appellant being notified of the written decision.
- 10.3 The Legal Section considered this report on 21 July 2023 (IKEN 12182-EBC-MW).

11 Risk management implications





S 19; mandatory conditions where licence authorises supply of alcohol

- 1. No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (e) dispensing directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 6. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;

- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
 - (b) "permitted price" is the price found by applying the formula—

$$P=D+(DxV)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the operating schedule

a) Customers will be asked not to stand around talking in the street outside the premises and will be asked to leave the vicinity quickly and quietly.

CCTV:

- a) Digital CCTV and appropriate recording equipment to be installed in accordance with Home Office Guidelines relating to UK Police Requirements for Digital CCTV System (current PSDB Publication), operated and maintained throughout the premises internally and externally to cover all public areas, including the entrance to the premises. The system shall be on and recording at all times the premises licence is in operation.
- b) The CCTV cameras and recording equipment must be of sufficient quality to work in all lighting levels inside the premises at all times.
- c) CCTV footage will be stored for a minimum of 31 days.
- d) The management will give full and immediate cooperation and technical assistance to the Police in the event that CCTV footage is required for the prevention and detection of suspected or alleged crime.
- e) The CCTV images will record and display dates and times, and these times will be checked regularly to ensure their accuracy.
- f) Subject to GDPR guidance and legislation, the management of the premises will ensure that key staff are fully trained in the operation of the CCTV and will be able to download selected footage onto a disk (or other electronic portable device acceptable to Sussex Police) for the police without difficulty or delay and without charge to Sussex Police.
- g) Any breakdown or system failure will be notified to the police immediately & remedied as soon as is practicable.
- h) In the event of the CCTV system hard drive being seized as evidence as part of a criminal investigation by Sussex Police or for any other reason, the premises will be expected to install a replacement hard drive or a temporary replacement drive as soon as practicable.

Training/Authorisation:

- a) The Premises Licence Holder shall ensure that all staff members engaged, or to be engaged, in selling alcohol at the premises shall receive the following induction training. This training will take place prior to the selling of such products:
 - *The lawful selling of age restricted products
 - *Refusing the sale of alcohol to a person who is drunk

- b) Further verbal reinforcement/refresher training covering the above will be carried out thereafter at intervals not to exceed 6 weeks, with the date and time of the verbal reinforcement/refresher training documented.
- c) All such training undertaken by staff members shall be fully documented and recorded and signed by both the employee and the DPS. All training records shall be kept on the premises and made available to Sussex Police, officers of the local authority and officers from the Trading Standards team upon request.
- d) A list of staff members who are authorised to sell alcohol on the premises shall be kept. This shall be endorsed by the DPS with the date such authorisation commences.

Challenge 25:

- a) The premises will operate an age verification policy set at a minimum of 25 years (e.g. "Challenge 25") whereby any person attempting to buy alcohol who appears to be under the specified age e.g. 25 will be asked for photographic ID to prove their age. The recommended forms of ID that will be accepted are passports, official Photographic Identity Cards issued by EU states bearing a hologram or ultraviolet feature, driving licences with a photograph, photographic military ID or proof of age cards bearing the 'PASS' mark hologram.
- b) Signage advertising the age verification or 'Challenge 25' policy will be displayed in prominent locations in the premises.
- c) Children must be supervised by an adult at all times.

Incident Log:

- a) An incident log will be maintained by the premises showing a detailed note of incidents that occur in the premises. The log will be inspected and signed off by the DPS (or a person with delegated authority) at least once every 4 weeks.
- b) The log book should be kept on the premises and be available for inspection at all times the premises are open by authorised officers of the Licensing Authority or the police. An incident will be defined as being one which involves an allegation of a criminal offence.
- c) Feedback shall be given to staff to ensure these are used on each occasion that a refusal or incident occurs at the premises.
- d) Any refusals made for alcohol service e.g. underage, will also be recorded (either in electronic or written form) and feedback given to staff as relevant. The log will be kept at the premises for a minimum of twenty four (24) months.


Off Sales

- a) All sales of alcohol, for consumption off the premises, to be made in a sealed container.
- b) No glass receptacles will be used for take away orders.
- c) Alcohol shall only be sold for consumption off the premises in conjunction with the sale of food for takeaway.
- d) A minimum spend of £8 of food for take away must be made before alcohol can be purchased.

e) No beer, lager or cider with an ABV of 6.5% or above, will be stocked, displayed for sale or sold.

We are writing to express our objection to the above application by Shoes Simes to vary the premises licence for the Glass House, Pavilion Gardens, Royal Parade.

We object on two grounds

First we object to the late night opening being sought. Being open to the public between I and 2am every night of the week will cause significant noise pollution from customers and music emanating from the building, particularly in the summer months, when windows and doors will be open and customers will want to be outside on the large terrace. Customers leaving the venue will also be noisy which will extend the disruption beyond the licencing hours.

We run a small successful bed and breakfast directly opposite the Glass House. Our guests value the peace and quiet offered by our location. Our sea view rooms in particular are very popular and command a premium. We fear that future guests will be significantly disturbed by the opening to 2am and will not only not return, but will complain on the social media and the likes of Trip Advisor which will adversely affect our future business.

Our concerns are based on our past experience when late night opening in the Pavilion, for a wedding, caused guest complaints from noise disturbance, such that Environmental Health were called and the event closed in the early hours due to a breach of acceptable noise limits. The problem was exacerbated by the guests spilling out onto the terrace and the windows and doors being open. No amount of 'good management' would have been able to prevent 50 plus rowdy, inebriated guests from partying outside.

Second we object to the amendment being sought to remove the condition that alcohol can only be served with food.... This is supposed to be a restaurant not a pub. Therefore it is reasonable for customers to be eating when drinking. If alcohol only sales are allowed there is a real risk alcohol will be purchased to take away and be consumed in the gardens and or the beach. There is already a problem of anti-social behaviour and drinking in the gardens at night during the summer. The on site availability of alcohol will exacerbate this problem.

Despite our objections we are very supportive of the planned Glass House and the plans Shoes has for it as a restaurant. It is therefore greatly disappointing that there has been no prior consultation with neighbours on this licensing amendment. In our view the existing licensing hours for the premises and conditions should not be changed. We do however understand that at the request of neighbours Shoes has agreed to a meeting, but this has not yet been arranged. We hope that at the meeting the strength of feeling against this amendment will persuade Shoes to leave the opening times and conditions of sale as they

presently stand. If Shoes is not however persuaded, we hope and trust the licensing committee will refuse this application.

Finally we read from the application posted on the buildings main entrance door, that there is reference to 'Change to Site Plan – see attachment'. As of 8pm on 15 June, no such plan was attached with the notice. See attached photo

The above application has been made by Shoes Simes to vary the premises licence for the re-named "Glass House", Pavilion Gardens, Royal Parade.

Despite our general support for her new Restaurant venture, we had not been made aware of her intentions to amend the licence or change the site plan in this way. (we have still not seen details of the changes to the site plan). Along with other business colleagues on Royal Parade we are therefore objecting to these proposals and request that application is refused.

Firstly we object to the extended late night opening being sought.

We run a small successful bed and breakfast on Royal Parade, not far from the Glass House. Most of our guests prefer the quieter sea front environment here offered by our location. In particular, our front facing sea view rooms are very popular. We fear that future guests will be disturbed by the noise generated by customers and music in the early morning, followed by cleaning and re-setting tasks after closure. Late night drinking will also lead to loud disturbances from people leaving the Glass House after closure. This will present a serious problem during the summer peak business months when our guests prefer to have windows open. Our guests will complain to us about the extended opening hours to 2am and will not return. They will also no doubt complain on social media and in reviews to Trip Advisor, Booking.com and Google which are the source of 50% of our business. Such disturbances arising from occasional extended openings in the past are already on record with the Police and other public safety organisations.

Secondly we object to the amendment being sought to remove the condition that alcohol can only be served with food.

The modification of the re-named venue has always been "sold" to us as a good quality restaurant and was therefore a welcome improvement on previous offerings. Until recently there had been no indication or discussion with local businesses and residents that it would be anything else. It is reasonable for us therefore to expect customers to be eating when drinking.

If alcohol only sales are allowed there is a real risk that alcohol will be purchased to take away and be consumed in the gardens and/or the beach. There is already a problem of antisocial behaviour and drinking in the gardens at night during the summer. The on site availability of alcohol will exacerbate this problem.

Summary

It is greatly disappointing that there has been no prior consultation with neighbours on this licensing amendment. In our view the existing licensing hours for the premises and alcohol sales conditions should not be changed.

We are, nevertheless, hoping to meet with Shoes as a group to ask her to withdraw the application but a date has not yet been arranged. However, if Shoes is not persuaded, we hope and trust the licensing committee will refuse this application for a variation of existing current restrictions.

We are writing to register our objection to the application for a premises licence by Shoes Simes at the above.

We live and run a business of holiday accommodation directly opposite the Glass House.

Our guests are varied and regularly include families with young children as well as older people.

Businesses and residents in this area already suffer noise nuisance and antisocial behaviour at all hours of the day and night from users of the park, gym and more recently the new wood cabin style seated areas as people congregate, play music and drink alcohol.

The noise from live music to 11pm 7 days a week and recorded music to 1am and 2am seven days a week would be extremely damaging to our business as we are able to clearly hear music from the building. During the summer months when doors and windows are open it would be even worse.

People leaving the premises, often under the influence of alcohol would be noisy walking directly past our property.

Taxi's would be arriving late at night using the kerb each side of the seafront road to pick up people, doors slamming from cars and the additional parking and traffic directly around us would put more pressure on a very busy road, the surrounding roads and to residents and guest parking.

The late night opening times would attract people from other pubs looking to carrying on their drinking after other premises close.

For a small sum of £8.00 minimum spend on food, alcohol may be sold in quantity and consumed outside of the Glass House, in the gardens and on the beach, glass and litter being left behind.

In an area where there is already a problem with alcohol abuse this would be further damaging for our area.

We rely heavily on good reviews from our guests promoting our business and the mention of late night party/club music, poor sleep, woken children and antisocial behaviour directly outside our property would be extremely damaging to us and all of the local businesses nearby not to mention the disruption to ourselves as residents.

I am writing to object to the proposed change to alcohol licensing at the premises to be called The Glass House, Royal Parade, Eastbourne, BN22 7AQ as posted by Shoes Simes on 12/6/23.

I do not object to the change of activities introducing film, theatre and weddings - this will be a good addition to the neighbourhood and make use of the wonderful venue in the pavilion gardens. However, the extension of the alcohol licensing and allowing alcohol to be purchased for takeaway could pose serious difficulties for our neighbourhood.

I object to the late extension of the alcohol and recorded music licensing, particularly in the middle of the week. Closing sales of alcohol at I Ipm Sunday - Thursday; and Iam Friday and Saturday seems reasonable. If sales continue beyond these times residents will be disturbed (as it is another 30-40minutes after a bar closes before guests are asked to leave a venue) and it is more likely that incidences of disturbing residents, property damage, fighting etc might occur.

There are many families in this area and older people. The area has seen much improvement in the last couple of years with police starting to address drug dealers coming from Seaside and other anti-social behaviour. We do not want to see a return to excessive street drinking, drug-selling or damage to property.

As far as I can tell, there is also no outline of security or support to prevent drinkers and guests at The Glass House spilling into the surrounding streets, or considerations of things like rubbish. I am writing to object to the The Glass House alcohol license, specifically in regards to them being allowed to serve alcohol and play music beyond 10:30PM.

I own a Bed and Breakfast called REDACTED that is very close to where The Glass House is located, just across the road at 62 Royal Parade. My guests enjoy our location specifically because it is away from the town centre, and thus it is quiet and away from drunks. On occasion we have already had problems with noisy drunks either in the park or wandering the street late at night, and I have had to confront them on multiple occasions asking them to be quiet or to move so that my guests and I can sleep. On at least two occasions the police had to be called to remove these noisy, drunk, in one case aggressive, and disorderly people. Having The Glass House serving alcohol late into the night will exacerbate this problem and cause a great deal of stress to myself, my neighbours and the police who will no doubt have to be called with much greater frequency.

I am of course sympathetic towards people who want to invest in the area, and I have no problem with The Glass House being open at ACCEPTABLE hours. Being open and playing music beyond I0:30PM is UNACCEPTABLE. That is too late and will do damage to my business and the people who live nearby, and it will no doubt be a nightmare for all of the people who have moved into the recently refurbished Heatherleigh flats, as many of them have to go to work in the morning. Even with the closing time of I0:30PM, it is likely that many of the people who are drinking there will stay for at least 30 minutes more in the park, so preferably I would like to see it closed even earlier, but I0:30PM is the very latest that would be acceptable.

I am writing to raise my concern to the notice which has appeared on the old Pavilion Building in the Pavilion Gardens to amend the existing alcohol licence by Shoes Simes for the new Glass House Restaurant. I am particularly concerned about the proposed late opening hours, which are up to 2am at weekends and up to Iam during the week.

I, and other residents who live on the sea front close to Pavilion Gardens, are concerned that the noise from the premises late at night and extending into the early hours, which includes a large outside terrace, will significantly affect our quality of life. Many of us are not only residents, but also operate guest houses and B&B's. We fear that guests will be disturbed by the noise in the early hours extending beyond licensing hours as customers depart and walk to their parked cars in the side roads. As a result, our guests will most certainly complain and are unlikely to return. No doubt they will leave adverse reviews on the on-line review sites, which will deter other guests from booking and will be detrimental to the viability of our businesses.

Whilst we understand there is a professional relationship some council members have with Shoes, particularly through the Chamber of Commerce, we trust you are able to give careful consideration to our concerns and **support us in opposing this licence** variation.

Many of us have already submitted an objection and having asked for a meeting with Shoes are hopeful this will take place, although to date no meeting has been scheduled. We are extremely disappointed that no prior consultation took place before the variation was submitted. To date there has been considerable goodwill from all concerned towards Shoes new business. Whilst we remain very supportive of the new restaurant and the revitalisation of the gardens, this cannot be done at the expense of existing residents and hospitality businesses close by. Ironically it would be these same businesses which would recommend the Glass House to their guests.

APPLICATION FOR A FULL ALCOHOL LICENCE

I understand that an application has been made to convert the above premises into an active drinking establishment with long opening hours stretching into the early hours of the morning. As a local resident I wish to express my strong opposition to this proposal and would offer the following comments

- I. Is the setting up of a drinking establishment open to the early hours consistent with Council's 5 year plan? I would not have thought so as there is no precedent for such an establishment along the whole of the length of Eastbourne sea front/promenade. However the action taken recently not to develop Fisherman's Green suggests that the Council wishes to keep things as they are. The development of the Glass House would represent a massive change of use and therefore needs a far wider debate involving at least Regional media discussion and possibly even national media coverage including the local MP. In addition how does this proposal fit in with the Council's plans for the redevelopment of the Redoubt Fort.
- 2. I am struggling to understand what benefits will accrue to those already living in the area. The Glass House is situated in an exclusively residential with many residents having lived in the area for many years. In addition there are a number of hotels in the immediate vicinity that will no doubt start to lose trade once people realise that are staying across from a late opening establishment with live music until midnight. Hotels will start to close down thereby reducing the availability of hotel rooms a matter that is of concern to the Council.
- 3. The Glass House is situated across from the Pavilion Gardens and no matter what the applicants might say people will start to take over the gardens especially in late evening. The Council fought hard to get lottery monies to repair what was a run down drug-ridden area and it would be disastrous if all this good work were undone. I suspect this will give rise to a considerable amount of adverse publicity, which will impact upon Council members in the future. There are also memorial stones to fallen heroes that need to be protected.
- 4. The proposal is to convert a fairly flimsy wooden structure to what will be a very active pub. The original structure was never meant to be more than a restaurant and therefore any change of use will require an extensive revamp to accommodate all the proposed changes the applicant wishes to make. How confortable is the Council with this and how does it fit in the development of the Redoubt Fort.
- 5. Inevitably there will be anti social behaviour especially given the long hours the pub will be open. This will inevitably require more involvement from the Police and all the noise and interruption this will entail. Less than five years ago this area was known for its high drug use and I don't think it requires too much logic to think that history will not repeat itself. I think that customers (especially when drunk) could easily intimidate members of the public

taking a stroll. I also don't think it is stretching the truth to say that someone will eventually try a take a dip in the sea, whilst drunk which may not be their best choice.!

- 6. Noise pollution will also be an issue. Especially with live music until 12 and recorded music thereafter. You have only got to stand on the prom at Seahouses and listen to the music performed at the end of the pier to realise how far the noise of music can travel. In addition there is also the noise emanating from customers whose voices inevitably rise a few decibels when they have had a few. There will inevitably be raised voices at closing time as people leave the establishment. This will not help local people trying to get to sleep.
- 7. In addition there will inevitably be additional litter that does nothing to enhance the area and improve the image of Eastbourne. This will require the Council to foot the cost of additional cleaning resources which I would suggest could be spent in more beneficial ways
- 8. Clearly the development of this site will result in a considerable increase in traffic flows and the need for a lot more parking. Parking is already tight in the immediate area and this will not help.
- 9. One final point I would ask the Council to consider is the impact of such an establishment will have on the mental health of all the residents who will be affected by this development. This is such an important issue nowadays and is one I don't think the Council can readily ignore especially since many residents are elderly.

Conclusion

There may or may not be a business case for such an establishment but the site of the Glass House is not the answer and I would hope the Council will adopt a similar approach to that taken over Fisherman's Green. This is not a facility required by local residents with I suspect over 90% of clientele coming to the Glass House will be from outside the area. This is not fair on residents.

I fear the licensing authority is looking at the proposed benefits without considering the downsides in particular the late opening hours to 02.00 with live music to 12.00. These will obviously impact local residents especially the older ones. Mental health is a very important issue nowadays and one that should not be ignored

I would also emphases the large-scale nature of the application (including Wedding venue etc) could I fear easily gets out of control requiring the Police in particular to be actively involved in monitoring the activities of the Glass House and its customers; this at a time when police resources are severely stretched.

By all means approve such an application based in the country but not in an established residential area where demand from local residents for their services is minimal.

I will end with one thought – if this goes ahead I suspect, many residents will change their voting patterns certainly at the next local election and possibly at the next general election (if the local MP was to support this application)

My objections are numerous, although the one which worries me more than any other is specifically the volume of noise during unsociable hours. Having lived there during the time when homeless people were pitching tents on the Tearoom green opposite, I can personally guarantee that the noise will be insufferable for anyone dwelling nearby; it's proximity to and absence of barrier between the Glass House and local residents will result in disturbance so great that windows will have to remain closed at night. Noise of course will not be limited to emanating from the building itself - the combination of grounds and scenic location naturally lend themselves to being utilised as an extension of the premises. I cannot state strongly enough how disruptive the effects of late licensing will be to the immediate area, visitors and residents alike; to extend the licensing hours would pose a direct threat to our livelihood and many others. I am emailing to express my strong objection to some of the variations in the application for changes to the licensing, at The Glass House BN22 7AQ.

I fully support many of the proposed plans, and think that The Glass House will be an incredible asset to the surrounding community. However I am gravely concerned about the impact of the proposed extended music and alcohol licensing to the surrounding guest houses and private residences, and strongly oppose this application, beyond I I pm.

I run a small guest house directly opposite, and most of our guests choose to stay at this end of town as it is know to be quieter, suiting those wishing for a restful stay. We and all of the small guest houses along this part of the seafront rely heavily on good reviews and if you look at all of the properties at this end of the seafront, we are all rated as exceptional on booking.com, a big credit to Eastbourne's hospitality trade. However just a small number of complaints can bring your rating down immediately, which is then very hard to get back up. By extending the licensing hours beyond I Ipm and the inevitable noise pollution this will create, this in turn will result in unhappy guests and bad reviews, which will then be pushing our small businesses to the edge of being viable, devastating when we have all worked so hard to ourselves be an asset to Eastbourne, and a place people will be drawn back to stay in Eastbourne, time and again.

At the meeting Shoes Simes ran yesterday, her reassurance about the late license was that this was purely for if a nice table of guests wanted an extra drink at the end of the evening. However my concern is that should the application be approved this would pave the way for the Glass house then going from her description of mainly a restaurant, to a venue that may well be used for weddings or similar large functions, with noise going on into the small hours, which would have a catastrophic impact on all of the surrounding businesses.

Finally, I believe that the development of the site and the planned operating model will deliver an unquestionable asset to both the immediate vicinity and the wider town delivering employment, prosperity and an enhancement to both visitor and resident experience.
