

Consultation on changes to Eastbourne Borough Council taxi and private hire licensing guidance – consultation report

March 2021

Background

From 1st February to 26 March 2021 we consulted on proposed changes to our Taxi and Private Hire Licensing Guidance.

A statutory guidance document, issued by the Department for Transport to all Licensing Authorities in England and Wales, required us to look at our current guidance.

It recommended incorporating additional measures into our existing Taxi and Private Hire Guidance. This was with the intention of improving and updating existing measures to protect children, vulnerable adults and the wider public when using taxis and private hire vehicles.

As a result of these new standards the council has took the opportunity to review and update the whole Guidance Document.

The Council's Taxi and Private Hire Licensing Guidance sets out the terms and conditions that apply to those seeking licences for the Hackney Carriage or Private Hire trade. This is to protect the public and help ensure they receive a good service.

How we consulted

- We carried out a public consultation from 1st February to 26 March 2021.
- We published a page on the district council website which included the background to the review and the draft guidance.
- We provided an online survey for respondents to structure their feedback and made the offer of providing paper copies of this on request.
- We also offered the consultation information in different languages and formats.
- We publicised the consultation through the local media, our social media channels, via the council's website and by email to the council's consultation mailing list.

Next steps

- This report will be published on the council website.
- The report will be taken to the Licensing Committee on 24th May 2021.

• Once a decision has been made it will be published on the council website and shared with residents, drivers, operators and other stakeholders.
