		<ul> <li>Members questioned the generally positive nature of the Annual Report, whilst raising concerns about the findings in some areas, in the light of the HMICFRS PEEL inspection report considered later on the same agenda, particularly when evidence of good or improved performance in the Report was based on crime data that the Inspectorate had called into question.</li> </ul>
