Walk in trade for intoxicated night time clubbers will cause groups to remain in the area consuming food on front steps of residents properties. It is a human right to an undisturbed nights sleep ready for the working day. As residents we have witnessed many incidents over the past years, therefore any extension beyond 1.00am is not acceptable.
