Thank you for your response.

Good afternoon Kirstie

In your application you declared that you are NOT a vertical drinking establishment yet you are refusing to accept a condition which would ensure you are not a vertical drinking establishment.

On the plans you have submitted, they show empty rooms. Please can you clarify how many covers you plan on having, including how many bar stools.

There is one room which will be the cafe bar, the other is a small kitchenette. We will probably be able to fit around 6/7 tables and 12 bar stools - max 36/40 people seated.

You describe having a DJ on Friday and Saturday evenings, this again suggest it is a vertical drinking establishment.

This is not so that guests can dance but listen to interesting music.

10. Customers will not be permitted to take alcohol outside of the premises to consume whilst smoking, congregating or eating on the pavement outside of the premises. Only to be consumed whilst sitting down at a table.

Customers will be consuming drinks/alcohol and snacks on the bench or small table outside.

Customers will not be able to consume alcohol outside of your premises, if agreed, the only time they can will be when they are seated.

Ok, I will put up a sign to address this.

The outside area, can you show on the plans where your table and chairs will be, clarify how many please.

Outside the window, one table or bench with two seats.

Will you have a smoking area?

If so, how will this be controlled. Have you consulted with the council/highways and checked to see if you are allowed table and chairs outside of the property?

I have asked planning.

11. No alcohol to be consumed outside the front of the premises sitting on the bench or at the small table after 1800hrs.

Customers may want to go outside after 18.00hrs in the summer months as there isn't a garden. Customers will be consuming drinks/alcohol and snacks on the bench or small table outside. This will all be supervised by door staff, there will only be room for a couple of people outside at any one time.

Once my further questions above are answered I might be able to consider increasing this time.

I hope this answers your questions, please get back to me if not, this is my first application so please bear with me.

I will put signs to let guests know what they can and can't do.
