

Consultation on changes to Eastbourne Borough Council's Statement of Licensing Policy Cumulative Impact Assessment consultation report

December 2021

Background

From 20th October 2021 to 6th December 2021 we consulted on proposed changes to our Statement of Licensing Policy Cumulative Impact Assessment (CIA).

The Licensing Act 2003 ("the Act") requires Licensing Authorities to prepare and publish for a five-year period, a Policy for their area which apply when exercising its functions under the Act. Eastbourne Borough Councils current Licensing Policy runs from 2019-2024.

Licensing Authorities must review special policies (the CIA comes into this category) regularly. Section 5A (12) of the Licensing Act 2003 and Home Office Guidance issued under Section 182 Licensing Act 2003 states this should be every three years for such policies.

This consultation is purely about the CIA element of the Statement of Licensing Policy.

How we consulted

- We carried out a public consultation from 20th October to 6 December 2021.
- We published a page on the Borough Council website which included the background to the review and the draft guidance.
- We provided an online survey for respondents to structure their feedback and made the offer of providing paper copies of this on request.
- We also offered the consultation information in different languages and formats.
- We publicised the consultation through the local media, our social media channels, via the council's website and by email to the council's consultation mailing list.

Next steps

- This report will be published on the council website.
- The report will be taken to the Licensing Committee on 17th January 2022.
- An updated Statement of Licensing Policy will be submitted to Full Council for approval and published on our website.

1 Now all it needs is for it to be enforced 2 It's better to keep the Cumulative Impact Assessment as anti-social behaviour had hugely increased and the Police need to be able to be involved in each decision. The xxxx at The xxxx is turning what was a very quiet area into a nightmare and they don't care when you call them. With Covid, bars are leaving windows and doors wide open for ventilation but refuse to turn down the volume of music impacting their neighbours. Residents in the Town Centre have a right to quiet enjoyment of their homes and need the police to be involved in ALL decisions. Just in the last fortnight, we have had drug use and dealing by our home, numerous episodes of shouting/screaming past midnight, vomiting AND defecation near our home, (utterly disgusting) and a few nights ago a man urinated all over our front gate and into our entrance (blind drunk coming out of The *** Bar) meaning I had to go outside at 1am with a water hose to try to clean it all down before others (postman etc) ending up touching the gate. The anti-social behaviour from those pouring out of bars is out of control and definitely needs the input of the Police to ensure we as local residents aren't overwhelmed by anti-social behaviour by those pouring out of bars, clubs, pubs. What is also concerning is that bar owners now seem to care little as they are much more concerned about making money than caring about their neighbours and some are playing live music well beyond what their licence allows. Please keep the Cumulative Impact Assessment so that the Police can always be involved to try to cut down the huge amount of anti-social behaviour which is hellish for town centre residents. Thank you. I live on Susans Road in the centre of town. The police need to be involved in making decisions around licensing as this largely residential area away from the main drag struggles to cope with the imapct of the number of places with licences as it is e.g anti social behaviour. This is watered down. We have lived with excessive loud music and shouting customer noise from nearby beer gardens, the council has done very little over the last 6 months. And still, why allow options of 2am!? Eh, no, this is not solving any ASB or attached problems in late venues. This is all so dissapointing.

5	As someone who has to endure seven nights a week the impact of two
	late night bars until the early hours, this is something that clearly needs
	to be addressed across the town. Outside areas in high residential
	areas should not be allowed after 11pm.

It would appear from the options provided above that the council is only looking at ways to curb and deter any hospitality businesses from flourishing within the town centre. With so many restrictions and potential policies no new business would want to open in Eastbourne and therefore we will be left with more empty units and run down buildings. The council need to look at ways of helping to encourage business growth in this sector and finds ways that are so constraint and high impact to control ASB. Since the CIA has been introduced I wouldn't say as a local resident I have noticed a positive impact. Without properly managed businesses people have taken to drinking on the streets or at home, causing greater ASB issues.
